INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund("Master Fund"), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

INVESTMENT PHILOSOPHY

We invest in best of breed businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Following the very weak September, the global stock market had a welcome recovery in October. This pattern is in line with historical trends. It is a positive sign to experience some normality in this context.

Over half of the S&P 500 companies have reported third quarter results already. Despite disappointing earnings amongst large technology-related businesses and the Dollar strengthening another +7%* over the quarter, index revenues and earnings continued rising. Overall results were led by the energy sector.

Whilst inflation risks remain uppermost in investor minds, US recession fears have also taken a toll on sentiment. With both the first and second quarters having delivered negative GDP results, the third quarter growth of $\pm 2.6\%$ was a welcome indication that the economy is still on a positive track. This was confirmed by continued strong consumption and retail sales growth despite weak consumer confidence. Whilst it may be an early comment to make, it seems that more calm is entering the currency markets, especially in the cases of Sterling and Euro against the Dollar. Should these October trends persist, this can support investor confidence to some degree.

The Federal Reserve's (Fed's) firm commitment to temper inflation remains the main capital market risk. Following their 2 November meeting and an expected further +75bps increase in their target rate to 4.0%, it is our perception that a major portion of this risk can become 'water under the bridge' after their December meeting. Arguments may then move rather towards how much smaller the further Fed rate rises may be. The Fed Fund December 2023 futures levels have recently softened to 4.6%*.

Logically, capital market sentiment remains at the mercy of US inflation. Second to that, some silver linings to investor sentiment may not be too far off. This may also stabilise the sharp Value/Growth rotation.


