INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund("Master Fund"), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

INVESTMENT PHILOSOPHY

We invest in best of breed businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Following a strong October, the global stock market (as reflected in the MSCI AC index) added another +7.6% performance in November for a total delivery of +14.0% over the two months (in US\$ terms). This plays well into the theme of a traditional year-end rally.

Whilst some may refer to the rally as simply a traditional one, we believe there are more fundamental aspects to the more positive investor sentiment. Jerome Powell, the Federal Reserve (Fed) Chair, commented that the Fed may by December already consider slowing the pace of interest rate increases. This is perceived as an important indication that their inflation-busting endeavours may be on track, albeit with general acceptance that rates still need to rise further. He further commented that an economic 'softish-landing is very plausible'. The ten-year Treasury yield has dropped from a recent peak of 4.2% to 3.6% at month end.

These small proverbial first swallows to the hopeful stock market summer also reflect in its technical picture. The S&P 500 index has already crossed three of its five important technical hurdles – its 50-day moving average, its Fibonacci golden ratio, and, right at month, end its 200-day moving average. Technically minded investors are holding breath for the major technical resistance at an index level of 4,100, just \pm 0.4% from its current value.

Under normal capital market circumstances these are relatively minor considerations. Fundamentally- orientated investors, though, are now intensely focussed on whether we are potentially entering a new phase with softening fears of a worst-case inflation and interest rate scenario, and more indications of these issues getting under control in 2023. The 13 December announcement of the November US inflation number, and the Fed's meeting the following day, may shed some further light in this context. With US stock market short interest close to record levels and with a similar picture of asset manager cash levels, the bears may now be less inclined to increase their positions.


