## INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund ("Master Fund"), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

We invest in best in class businesses for their quality, strategic competitive edge and value.

## FUND COMMENTARY

Stock markets recovered strongly in May, with the MSCI ACTR Index appreciating by +5.8% and the S&P 500 Index by +6.2%, outperforming the other major international markets for the first time this year. These are strong recoveries of +18.8% and +18.7% from their respective Liberation Day-related low levels on 8 April, bringing both indices into positive territory for the year (all data in USD). The US Technology sector recovered particularly well.

This strong performance is predominantly ascribed to the US administrations' announcement on 8 April of a 90-day tariff negotiation period, followed by immediate intense negotiations and some important resolutions. The lowering of tariffs from 145% to 30% on China, with a reciprocal lowering from 125% to 10% on the US, along with the UK quickly reaching a trade agreement, all played a major role in calming investor nerves globally. News flow on tariffs has become much more constructive than the earlier shocks, but investors remain aware that risks in this context remain high.

Whilst hard US economic data remains constructive, the leading soft economic data reflects a potentially weakening economic outlook. It is a constructive signal that US inflation and bond yields have remained under control. US companies have delivered strong first quarter results, with S&P 500 Index sales growing by +5% and earnings by +12%, exceeding expectations by +1% and +8% respectively. The continued increase in overall profitability is a striking feature.

The best contributors to Fund performance over the month have been Microsoft, GE Aerospace and Amphenol. Whilst GE Aerospace benefits from strong structural demand, Microsoft and Amphenol benefit from the strong technology recovery following the earlier sell-offs. The largest detractors were Copart, EssilorLuxottica and Cadence Design Systems. Copart suffered from weaker than expected results. EssilorLuxottica lagged the strong market recovery following its earlier strong outperformance, while Cadence dropped on the US administration's ruling of the need for licenses for exports to China.

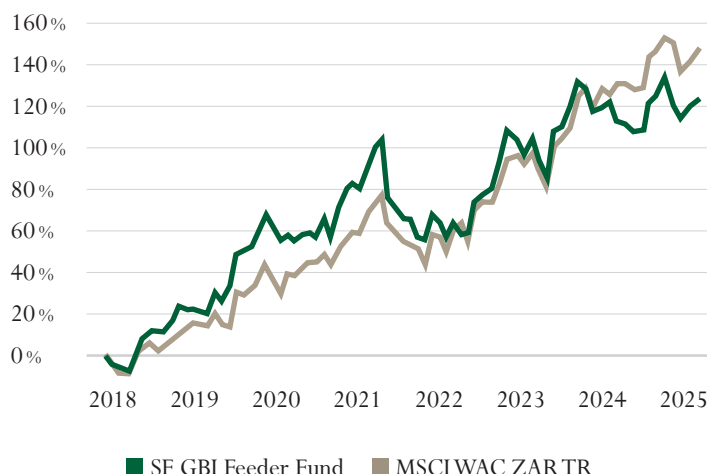

## IMPORTANT INFORMATION

A **Feeder Fund** is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.
