FUND COMMENTARY

Equity markets delivered strong results in August. The World index (MSCI World AC) grew by +6.0% over the month, following an already strong +5.1% in July, and continuing its steep recovery process since the bottom on 23 March. The index has now recovered into positive territory for the year thus far.

August delivered its best performance since the inception of the index in 1988. This is in sharp contrast to the weak traditional seasonal performance over the summer quarter (on average, August has delivered negative returns historically).

Many investors, under normal circumstances, consider the traditional third quarter weakness as an opportune time to invest ahead of the fourth quarter, which has historically delivered the best average returns. September, in particular, has been the weakest month historically.

The natural question this year is what difference the upcoming US presidential election can make. We dare not, of course, try to forecast the outcome, but realise the main challenges each candidate faces are the revival of economic growth and unemployment. We can, though, take cognisance of historical trends over the coming months during election years.

Interestingly, during election years, the S&P 500 index has historically continued its traditional negative September performance, but at a milder level than usual. Strikingly, October has been the weakest month of the year during election years while it has otherwise been a strong month. Then, back to tradition, November and December during election years have been of the strongest months.

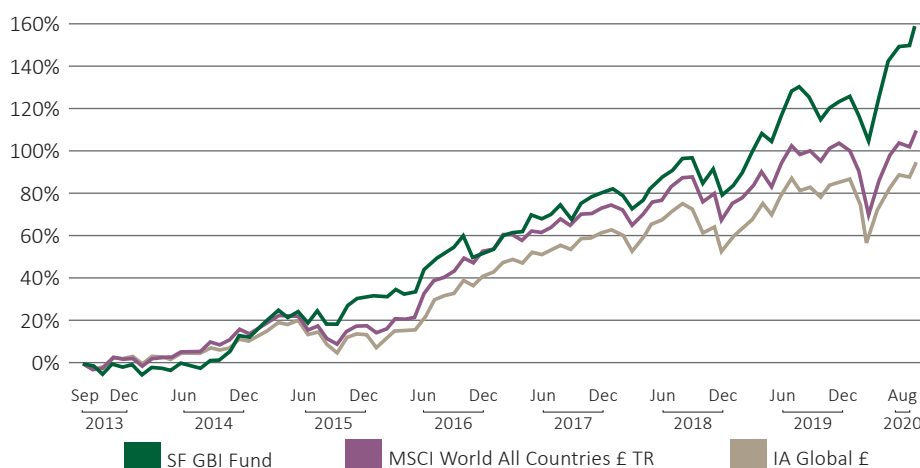
Of course, we invest with our eye on the investment horizon, but with many uncertainties around the election, we will not be overly surprised if history repeats itself to some degree in this context. We are also conscious of many investors eagerly awaiting potential investment opportunities.

The Fund is a sub-fund of the Stonehage Fleming Pooled Investments (Ireland) plc (the "Company"), an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 525228. It qualifies and is authorised in Ireland by the Central Bank of Ireland as an Undertaking for Collective Investment in Transferable Securities ("UCITS").

The Company is recognised as a section 264 scheme by the Financial Conduct Authority in the United Kingdom. The Fund is an approved Foreign Collective Investment Scheme in South Africa where it is registered with the Financial Sector Conduct Authority (South Africa). The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription,

sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
