To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

FUND COMMENTARY

Following the strong global stock market performance during July and the usually dull summer season, investors should not be overly surprised by the weak delivery during August. Around half the gains of July have been lost.

Whilst inflation and interest rates remain uppermost in investors' minds, the good news of the 0.6% drop in US headline inflation excited the market. This was followed by the Jackson Hole economic symposium of Central Bankers, policymakers and economists where it became clear that the Federal Reserve (Fed) remains very hawkish and may stay on their aggressive tightening programme for a while. Interest rates immediately followed suit with the US ten year Treasury yield rising above 3%. Further Dollar strength followed, with the greenback strengthening to a 20-year record. China locked down another major city (Chengdu) to curb Covid. With the US reporting season completed and little further news on the corporate front, softening stock market sentiment unsurprisingly followed.

It is right for the Fed to stay firm in its stance on curbing inflation, despite the promising signs of peaking US headline inflation. It remains our perception that the key reasons for the weak stock market performance over the first half of the year are in the process of stabilising.

With a dull economic outlook, good organic business growth will become even scarcer to find. We believe the digital revolution and health care sectors continue to be attractive sectors in this context and, equally importantly, those being able to continue generating strong free cash flow. We expect our portfolio of business to compound their revenue and earnings growth respectively at $\pm 10\%$ p.a. and $\pm 13\%$ p.a. over the coming three years. This is the level of growth that investors need for sustainable longer-term investment performance.


