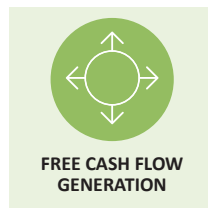

FUND COMMENTARY

Investment returns for 2019 turned out better than most expectations. This can mainly be attributed to continuing low global inflation and the benefits of monetary easing in many economies, keeping interest rate levels at bay and postponing the next US recession. The absence of material fundamental economic imbalances in the US economy is also an important factor.

Investors may wonder whether such a strong year can be followed by reasonable results the following year. Considering historical experiences, the MSCI World AC price index appreciated by +24.1% last year while there have been only seven other occasions of more than +20% gains since the index's inception in 1988. The average result the ensuing year was positive, with two negative years.

The S&P 500 index has a longer history. Considering its data over the past 50 years, there have been 13 occasions of +25% results. Nine of the following years delivered positive results. The average year two result was +11.2% (with the median result of +11.4%). This compares well with the 50-year average of +10.6%. Notably, both the negative occasions (1981 and 1990) led into the respective US recessions.

While 2019 may be perceived as an exceptionally high base to improve upon, it obviously succeeded a low 2018 base. The year ended only +10.2% above the peak level in 2018. The compounded growth rate over the two years is +11.9% p.a., close to the 50-year average mentioned above. In this context, it therefore seems that 'normality still prevails'.

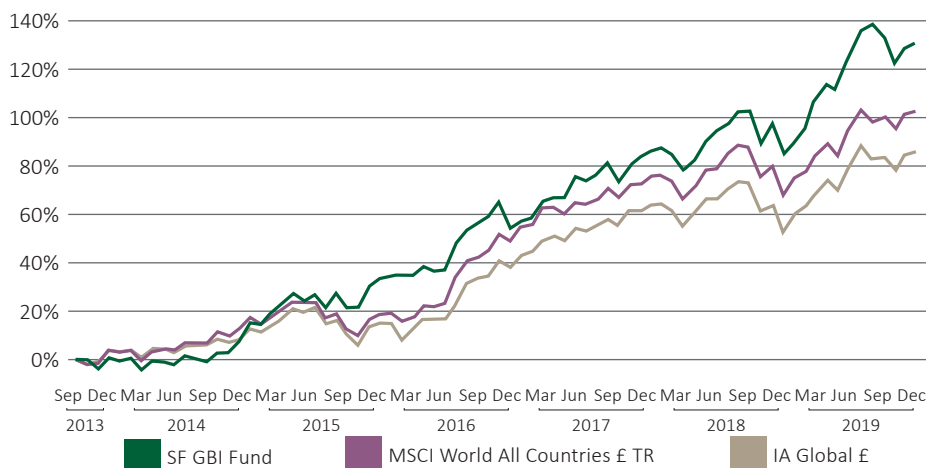
We continue with our view of a 'stretched out' soft landing for the US economy. The global economic outlook seems stable with more signs of improvement than material further deterioration, especially in China. Questions are being raised on when business results may start to improve, rather than fearing too much the current relatively soft patch in some sectors.

All returns in commentary above are stated in USD.

The Fund is a sub-fund of the Stonehage Fleming Pooled Investments (Ireland) plc (the "Company"), an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 525228. It qualifies and is authorised in Ireland by the Central Bank of Ireland as an Undertaking for Collective Investment in Transferable Securities ("UCITS").

The Company is recognised as a section 264 scheme by the Financial Conduct Authority in the United Kingdom. The Fund is an approved Foreign Collective Investment Scheme in South Africa where it is registered with the Financial Sector Conduct Authority (South Africa). The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription,

sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
