INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund (“Master Fund”), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best of breed businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

The leap month delivered a strong Dollar return of +4.3% for the MSCI ACWI Index. Equity markets have been supported predominantly by US inflation continuing to drift lower, US consumer confidence further strengthening, their economy remaining resilient and a positive US earnings season.

This relatively benign backdrop, with a general perception of a ‘soft landing’ US economy this year, result in a stable US bond market. Our view is that the Federal Reserve can bide its time to lower their target rate, but that this overall combination of capital market factors can continue to support growth equities.

There continues to be little reason for material optimism on the possibility of a sustained recovery of the Chinese economy. Geopolitical and various national election risks continue to affect investor sentiment. Whilst the Red Sea attacks may only impact around 12% of world trade, it does delay the availability of containers with the result being rising shipping costs with potential for some inflationary risks.

Whilst the overall S&P 500 earnings season delivered only a marginal positive result, the standout positive contributions came from the Communications, Discretionary, Industrial and Financial sectors. Included amongst these, good results were delivered by many Technology related businesses. Our Fund benefitted in this context (e.g. Alphabet, Amazon). On the reverse, Energy, Materials and Health Care detracted from index results. Our Health Care names, though, delivered well on this front (e.g. Stryker, Edwards Lifesciences, UnitedHealth). ASML and Cadence Design Systems delivered well for us in the Technology sector.

A positive factor from China currently is the sharp recovery in the number of their international travellers (+37% since November). This bodes well for luxury goods (e.g. LVMH) and cosmetics (e.g. L’Oréal, Estée Lauder) businesses.

The best contributors to the February performance have been Amazon, ASML and Linde. The largest detractors were Adobe, S&P Global and Nestlé.

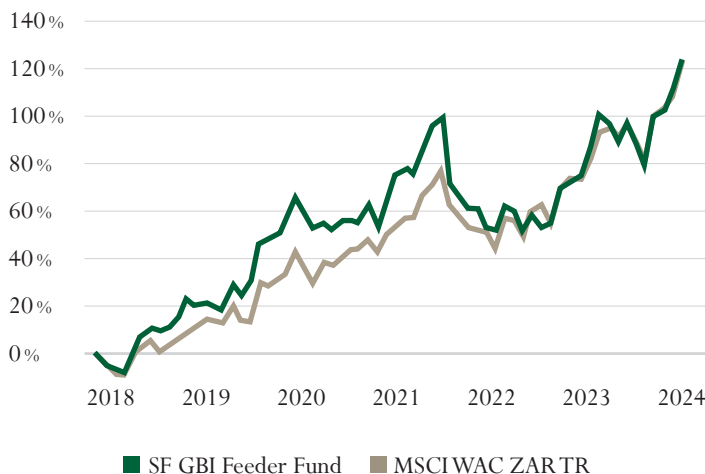
