What is this product?

Type: The Fund is domiciled in Ireland and is an open-ended investment company ("OEIC") and qualifies as an undertaking for collective investment in transferable securities ("UCITS").

Intended retail investor: The Fund is suitable for investors seeking long term capital appreciation and capital preservation with an initial subscription of USD 5,000,000.

Term: This Fund has no maturity date.

Objectives:

The Fund aims to preserve capital in the medium term and to achieve capital growth in real terms over the longer term.

The Fund intends to invest predominantly in a range of underlying collective investment schemes which will provide exposure to a portfolio of assets comprising mostly global equities and equity related securities, cash and high grade bonds. They may also provide exposure to other elements, including, non-investment grade debt, commodities, infrastructure and property exposure. Subject to the Fund's objective, policies and investment powers, the Investment Manager is allowed to make discretionary choices when deciding which investments should be held in the Fund. The Fund has no specific target market or geographic sector.

The Fund performance will be measured against the Morningstar USD Moderate Allocation Category Average (the "Benchmark").

The Fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

What are the risks and what could I get in return?

We have classified this product as 3 out of 7, which is a mediumlow risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The value of your investment may fall and you may not get back the amount you invested.

What happens if the Company is unable to pay out?

If the Company is not able to pay what is owed to you, you are not covered by any national compensation scheme. To protect you, the assets of the Sub-Fund are held with a separate company, a depositary. Should the Company default, the Depositary would liquidate the investments and distribute the proceeds to the investors. However, in the worst case, you could lose your entire investment.

What are the costs?

Costs over time
