INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund (“Master Fund”), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Stock market performance over July was volatile, driven largely by lower US inflation and a growing perception of a change in Federal Reserve policy and that their first rate cut is getting closer. This further supports investor perception that the general interest rate trend is firmly downwards, which will be supportive of smaller businesses. This triggered a large scale rotation from large capitalisation, higher valued (predominantly Technology related) stocks to lower valued, smaller capitalisation stocks that have been left behind for long. For example, the Small Cap Russell 2000 Index outperformed the S&P 500 Index by 9% and the S&P Value Index outperformed the S&P Growth Index by 6% over the month. The best performing sectors have been Real Estate, Utilities and Financials, with Information Technology and Communication Services the key laggards. This is already known as “The Great Rotation”.

The second quarter reporting season is in full swing (almost two thirds of the S&P 500 constituents have already reported). Overall results are pleasing (with index earnings +11%), with both top and bottom-line results delivering positive surprises against consensus expectations. That said, disappointment in results or management’s growth outlook was severely punished in many cases, adding to the Great Rotation volatility.

Our Fund’s investment philosophy is contrary to this Great Rotation and suffered from that. Five of the six worst contributors to performance over the month are Technology related businesses. Of the three worst stock market performers, Microsoft delivered a strong operational result (+15% top-line), with their Azure Cloud business doing particularly well. Cadence Design Systems’ results exceeded expectations, with a constructive cyclical outlook. The worst stock market performer was Edwards Lifesciences. They lowered their heart valve sales outlook and announced three acquisitions.

The best contributors to performance have been United Health, S&P Global and AJ Gallagher. They all declared pleasing results.

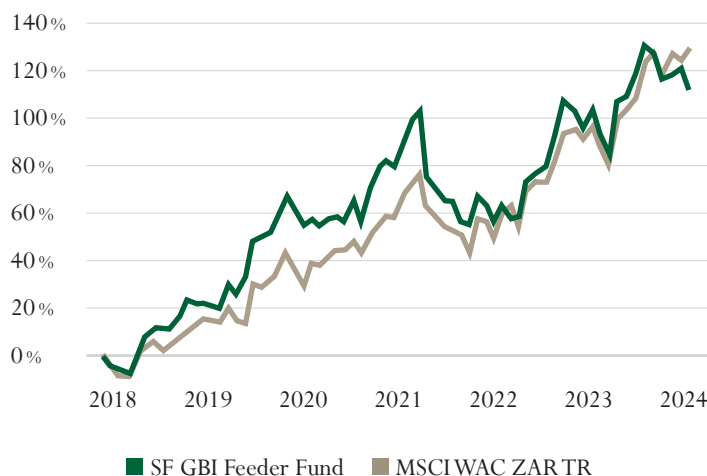
