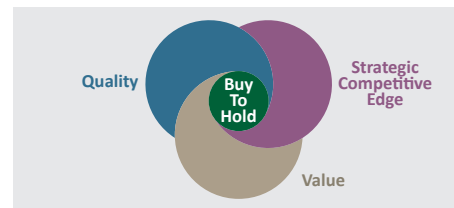

INVESTMENT PHILOSOPHY



INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund (“Master Fund”), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

INVESTMENT PHILOSOPHY

We invest in best of breed businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

World capital markets were overshadowed in July by the collapse of many internationally-listed Chinese technology stocks. Since its peak in February, the Hang Seng Information Technology index had already lost 24.5% by the end of June. It lost another 16.8% in July alone.

The Chinese political backdrop is complex, but in our perception can be summarised briefly as follows: Their government for the past two decades has focussed mainly on growth and efficiency and they have largely succeeded. They are now rebalancing the economy more towards common prosperity and social responsibility. Support for and protection of the population against excessive capitalist practises necessitate more regulation of multiple industries. Housing, Health Care and Education are particularly vulnerable in this context.

The Technology Sector is absolutely key in the above as it is to their global ambitions. It has outgrown its regulation, which now needs a material update. We believe the blocking of the Ant Group’s IPO was a responsible act in this context. As with the US administration, cyber security, the protection of personal data and anti-monopolistic actions are now a priority. This has many operational implications for various Chinese businesses. An incremental number of regulatory announcements over recent months has caused huge market volatility.

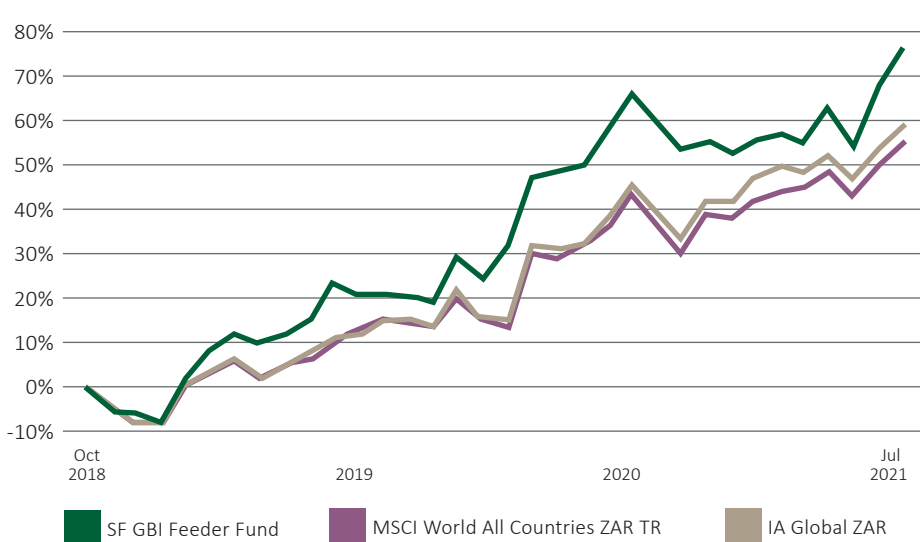
The recent Didi listing on the NYSE intensified investor anxiety even further. The Chinese regulator’s cyber probe two days after the IPO was initially perceived to be particularly harsh after the company raised \$4.4bn from investors. It, though, also transpired that the regulator did warn Didi beforehand, but that their private equity shareholders, in the absence of an outright order from the regulator to halt the IPO, wanted to proceed.

The risks of investing in China are now fully exposed and highlighted. The China risk premium has increased, with earnings projections and valuation multiples getting tempered. We expect the institutional market to stand back for a while and in the interim rather rely on US- or European-listed global operators to capitalise on the China growth potential.
