**FUND COMMENTARY**

The main feature of capital markets in June was the continuing lower interest rate levels despite a sharp spike in inflation, contrary to many (if not most) views a few weeks ago. The latest US CPI (Consumer Price Index) reading increased further to 5.0% and PCE (Private Consumer Expenditure), the Federal Reserve's preferred inflation measure, increased further to 3.1%. Both these inflation levels are well beyond their longer term target level of 2%. Against these inflation spikes, and the strong US economic recovery, the Ten Year US Treasury Yield dropped from a cycle peak of 1.74% in March to 1.47% at the end of June.

Federal Reserve chairman Powell is credited for allaying fears of structurally increasing inflation levels. He addressed the topic again on 22 June, reiterating his view that the inflation surge is attributed to factors mostly related to economic reopening and is merely 'transitory'. It seems the market is starting to put more weight to this view.

The above 0.27% drop in the Treasury yield, as moderate as it may sound, reflects an important change in investor perceptions – away from a hugely uncertain and volatile outlook to a more stable and constructive environment. This renewed confidence reflects well in the first half of the year return of +12.3% for the MSCI AC index.

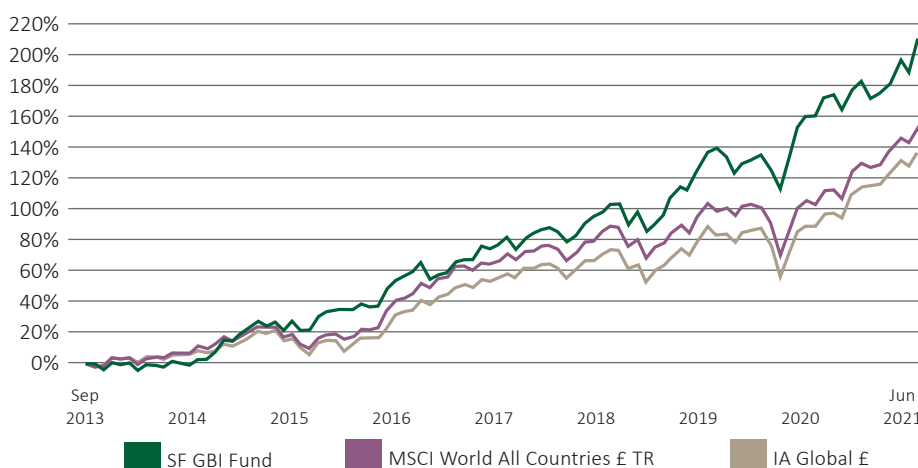
Investor considerations now seem to slowly move beyond the economic recovery and become more focussed on how to construct one's portfolio for sustainable solid earnings growth. Whilst the current outstanding overall company results can continue for a while, these high expectations have already become the general perception. Astute investors are starting to focus more on sustainable structural growth and are conscious of the risk of waiting too long in selling their more cyclical businesses.

The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from

the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
