## INVESTMENT OBJECTIVE

To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

We invest in best in class businesses for their quality, strategic competitive edge and value.

## FUND COMMENTARY

The equity market has experienced its worst performance for the first half of the year in over fifty years. Both the MSCI AC World and the S&P 500 indices delivered a -21% \$-performance\*. Given the potent combination of the global inflation scare, the new US central bank tightening cycle, the Ukraine war, the new and uncertain Federal Reserve quantitative tightening process and US recession fears, investors can be forgiven to rather watch circumstances unfold from the proverbial side-lines.

Considering over ninety years of S&P 500 index data, there has been only five occasions with a worse than -15% \$-performance in the first half of the year. The median performance over the successive second half years was +15%, with all occasions experiencing positive performances. The median performance over the successive June – June twelve-month periods was +27%. Amongst those were two marginally negative performances. They were respectively in 1939 and 1940 around the Great Depression and World War 2\*\*).

In our view, most investors' uncertainties currently boils down to US headline inflation. Core inflation has already rolled over with supply chain complications continuing to ease. In this context, container prices have already dropped close to their levels twelve months ago. Major mineral commodity prices are dropping, with wheat and corn now following suit. It therefore seems the oil price remains the main headline inflation challenge, leaving investors globally at the mercy of President Putin's war.

US Treasury yields may have peaked at 3.5% two weeks ago, but with the long tightening cycle lying ahead there is risk of an inverting yield curve with indications of a potential recession. US economic conditions, though, do not indicate material risk of either a deep recession or of stagflation. We keep concentrating on high quality companies that can continue delivering good earnings growth. Most candidates are currently on offer at attractive valuations.

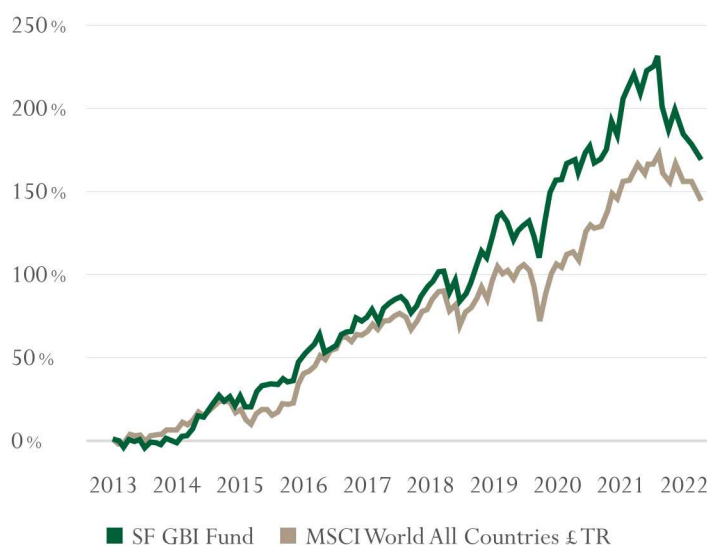
