INVESTMENT OBJECTIVE

To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

On a macro basis, world capital markets experienced a rather uneventful, but still a constructive month. US interest rates continued to drift lower and major share indices maintained a positive trend. Perceptions remain that US inflation is under control and that the Federal Reserve can start cutting their target rate towards the end of the year. US employment statistics and consumer sentiment are clearly cooling whilst, importantly, their balance sheet and debt service ratios remain sound.

More consumer companies are starting to indicate softening demand and have lowered their outlooks, particularly those exposed to low income consumers. The 'no landing' camp for the US economic outlook has become quiet, with a 'soft landing' view now more general. A more defensive stance has returned to investors' sentiment. Against this, the outlook for technology, and specifically for AI-related businesses, remains strong with vast opportunities for growth.

Following this comment, the three best contributors to our Fund's June performance again are from this category, both in terms of their absolute performances and relative contributions to overall performance. Amazon is trading at a record level, benefitting from its margin recovery theme. Adobe has experienced a strong recovery following its recent results and outlook announcements, alleviating some scepticism around their competitive position on the AI front. ASML and Cadence Design Systems – our semiconductor exposure – are also delivering.

The three worst contributors to performance over the month all have been in the global consumer space. Nike has been the largest detractor, delivering a soft earnings report and a particularly dampened outlook. L'Oréal announced a slower overall beauty market, with specific reference to China. This also directly affects Estée Lauder.

We have started building out a new position in the Industrial sector. It is a less cyclical type of business when compared to others in the same industry. We have not yet reached our target weight and will be building out the position in due course.


