INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund("Master Fund"), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Global stock markets delivered another strong month of performance in June. The S&P 500 index enjoyed a gain of +5.1% (in US\$ terms). The strong performance was largely a continuing relief rally from the April stock market lows following the Liberation Day tariff announcements, and then the 90-day negotiation period announcement shortly afterwards.

June offered further constructive news boosting the stock market. It is apparent that the AI sector is doing particularly well, supporting many US technology businesses whose shares have suffered since the China DeepSeek announcement early in the year and the revival of investor interest in Europe following increased European defence budgets attracting money away from the US.

Further to this, the Dollar depreciation accelerated in June, reaching a three-year low against a basket of trading currencies. This is expected to support the second quarter US earnings season. Good progress has been made on US tariff negotiations, particularly with China and the UK. Canada quickly withdrew their digital tax on US companies. Perceptions are growing that tariffs may settle around 10%, which would be much lower than initial fears.

Whilst June has been volatile in terms of Middle East politics, it seems that the aggressive bombing of Iran nuclear sites has effectively brought aggression to a standstill for the moment. Along with this, the oil price dropped sharply from its recent high, calming fears of potential economic and inflation effects.

We are conscious that both the US hard (more backward looking) and soft (more forward looking) economic data are currently in negative territory.

The largest contributors to portfolio performance over June have been Netflix, Microsoft and Amphenol. Whilst Netflix continues to benefit from high expectations for advertising income, Microsoft and Amphenol benefit from the US AI boom. The largest detractors have been AJ Gallagher, Zoetis and McDonald's. As more defensive type of businesses, they are neglected in the current relief/AI rally.
