FUND COMMENTARY

March delivered a strong global equity performance despite the fact that bond yields continued to rise at a sharp rate. For example, the ten-year US Treasury yield increased by almost a quarter from 1.41% to 1.74%, ending the month at a record level post January 2020 (before the Global Virus Crisis struck). The S&P 500 index also reached an all-time record level on 1 April. We believe this overall optimism reflects high expectations for a quick economic recovery, based mainly on the successful vaccination programmes and the US fiscal stimulus. We applaud modern science for bringing us to a much better place.

Whilst geopolitical risks always lurk in the back of investors' minds, we have recently become more conscious of just how varied these risks can be. The previous US administration took a harder stance against China in different forms, from trade sanctions to sanctions on politically sensitive industries (mostly in technology), to the delisting from US exchanges of businesses being controlled by a foreign government entity or those not complying with US audit requirements. The latter is a material risk to Chinese companies that are unwilling to give foreign regulators full access to their books. The new US administration seems to continue this stance.

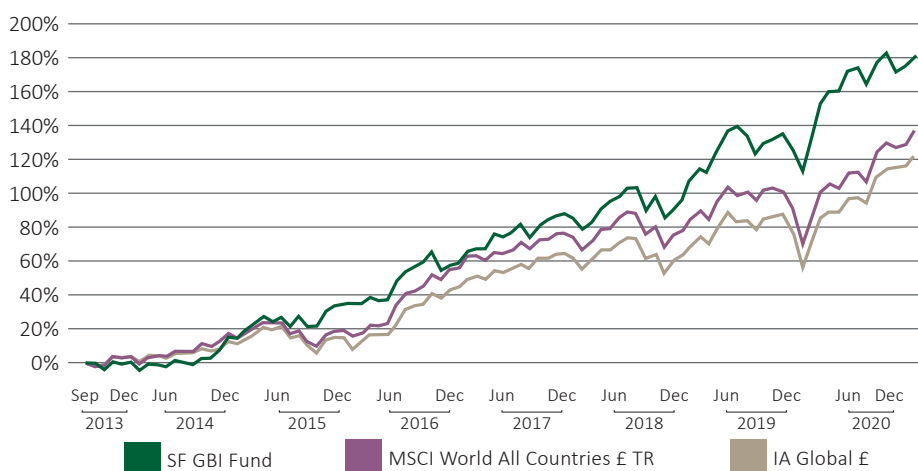
Chinese human rights are currently uppermost in many minds again. Statements by foreigners (whether historic or new) around forced labour practices in Xinjiang face a backlash from Chinese state media and e-commerce platforms. Some Western brands are suddenly not being offered on Chinese e-commerce sites anymore or are currently being boycotted by some Chinese consumers in favour of domestic ones.

Russian planes are continuously being intercepted over Europe and the North Sea (recently 10 times in a day). Global political tensions (including Taiwan, the Middle-East and Turkey) will most probably persist. Meanwhile, we realise neither the coronavirus nor its broad impacts will disappear anytime soon. We, therefore, relentlessly focus on the selection of businesses in which we have the highest conviction of sustainable growth.

The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription, sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from

the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
