INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund (“Master Fund”), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

True to historical patterns, the US stock market delivered a strong November. This follows the solid third quarter earnings reporting season, the clear outcome of the US election, interest rates dropping towards the end of the month and the first indications of some potentially positive geopolitical developments in the Middle East and Ukraine. The consolidated results of the S&P 500 index delivered a +1% revenue surprise and a +7% earnings surprise (the absolute growth numbers being +5% and +8% respectively). The election outcome reflects an undisputed new administration with expectations of lower corporate taxes and a more business friendly environment.

The best contributors to the Fund’s performance over the month have been Copart, Amazon and Cadence Design Systems. The shares all responded on their respective strong earnings reports, with the latter two already having reported in October, and their stocks continue to benefit. Copart continues to experience healthy vehicle salvage activity and benefits from the US hurricane season. It is also clear that non-insurance vehicle volumes offer further structural growth opportunities. In addition, whilst not so apparent in the public domain, it seems that they have quite materially increased the fees that buyers must pay. This contributes to a further rerating of the share.

L’Oréal and LVMH remained amongst the largest detractors to Fund performance. The continuing weak Chinese consumer market dampens their immediate outlook. Further to this, while investors have been expecting further Chinese government economic stimulatory announcements, it may now not be immediately forthcoming as the country’s leadership assesses the impact of the US election on China. Keyence’s detractor to Fund performance follows a muted factory automation cycle, the continuing weak Chinese economy and the volatility of the Yen currency.

We have not implemented any outright buys or sells over November.

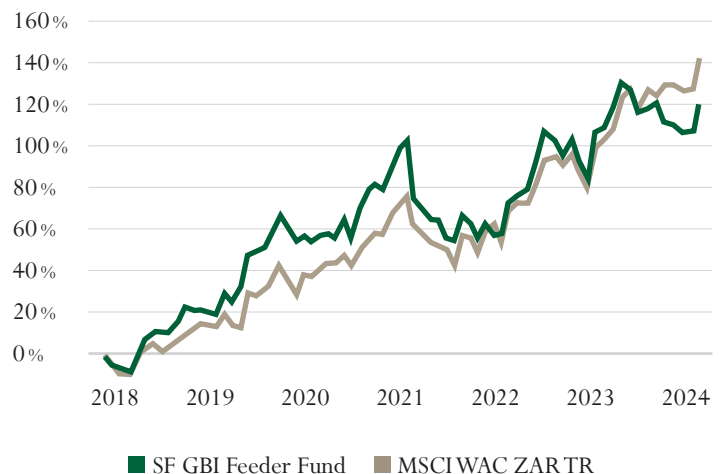
