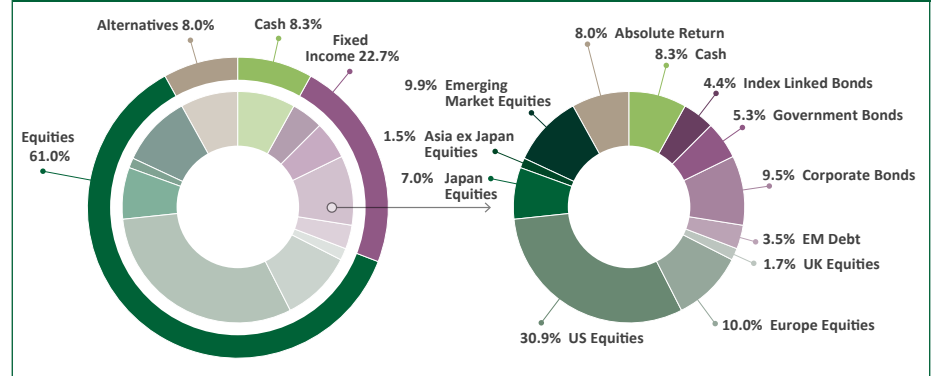
INVESTMENT OBJECTIVE
