# **PORTFOLIO COMMENTARY**

Risk assets surged forward in January, providing welcome relief to investors after the significant drawdown in the final quarter of 2018. Global Equities rose 7.9% (USD) with the US (+8.0% USD) and Emerging Markets (+8.8% USD) posting the strongest gains. These moves broadly reversed the losses incurred in December as the repricing of equities attracted many investors back into the market. Within Fixed Income, all sub-asset classes were positive over the month. Emerging Market Local Currency Debt was the standout performer but other areas of the market also made solid gains as investors re-engaged with corporate credit following December's drawdown.

Within the portfolio, our equity managers were led by the Conventum Lyrical Fund, which returned 13.2% (USD) over the month, outperforming US markets by more than 5%. In what was a difficult 2018 for the strategy, it was pleasing to see performance get off to a good start in 2019. Our Fixed Income positions performed very strongly, outperforming the Global Aggregate by 0.9% (USD) over the month. The exposure to Emerging Market Debt via BlackRock's strategy contributed positively as the strategy outperformed its benchmark thanks to tactical currency positioning. There was also a strong performance from the Pimco Income Fund, which outperformed the Global Aggregate by 0.9% (USD). As well as exposure to the Emerging Markets, Pimco also benefited from falling Government Bond yields as well as a rally in credit markets.

No significant changes were made to the portfolio over the month.

### **ACTIVE MANAGERS IN FOCUS**

### Man GLG Japan Core Alpha Equity

This strategy invests into large and mega cap Japanese equities with the aim of outperforming the TOPIX Index. The Fund is managed by Stephen Harker, who has over 30 years' experience investing into Japanese equities, and two supporting portfolio managers. The portfolio typically consists of 50 to 70 stocks and has a slight bias towards Value, whereby the Fund rotates out of stocks which have performed strongly and into names that are temporarily out of favour. The Fund is currently overweight Banks, Automakers and Real Estate names whilst remaining underweight Healthcare, Consumer Staples and Tech.

### Lyxor/Sandler US Equity Fund

Andrew Sandler is a broad market US long/short specialist with over 20 years' experience running this strategy. Portfolio construction is more dynamic than peers in terms of both stock selection and the management of net exposure; the latter is calibrated by their views of the top down environment, with special consideration given to the credit cycle. The strategy does have a Growth bias, which we feel the manager has the ability to moderate when the environment becomes less constructive. This should also contribute as a diversifier for the Value leaning characteristics of much of our existing US exposure.
