

PORTFOLIO COMMENTARY

The SF Global Growth Portfolio Fund returned 2.8% over the second quarter of 2018, versus the composite benchmark return of 3.7%.

Despite heightened volatility, global equities rose 6.9% in the second quarter of 2018. US equities outperformed, returning 9.7%, following strong economic growth in the US and upward revisions to GDP and company earnings. After a period of underperformance, UK equities performed strongly in Q2 returning 9.2%. Losses were made in the Emerging Markets in response to a strengthening US Dollar and concerns regarding trade protectionism.

The best performing position in the portfolio was within the US equity space. The iShares S&P 500 ETF tracked the index higher and benefited from the depreciation of Sterling resulting in a return of 11.3%. The SF Core UK Fund managed by Majedie also performed strongly returning 10.9%, benefiting from a position in Sainsbury's which rallied 38%. A key detractor from performance was our exposure to local emerging market debt via the Blackrock EM Local Currency Bond Fund. The Fund has fallen 8.0% so far this year due to deteriorating sentiment towards the asset class.

We restructured our Fixed Income positioning in May in response to developing market conditions. We reduced the Fund's government bond exposure and also fully redeemed our position in the Pimco Investment Grade Credit Fund. The proceeds of these trades were invested into the BlueBay Global Investment Grade Corporate Bond Fund and the Pimco Income Fund, exposing the portfolio to a broader range of fixed income assets. Both Funds are covered in our active manager focus this quarter.

ACTIVE MANAGERS IN FOCUS

The portfolio blends a mix of active, passive and factor strategies. Approximately 50% of the portfolio is invested in active managers where our conviction is the strongest. Below we outline two examples.

BlueBay Global Investment Grade Corporate Bond Fund

This strategy invests predominately into investment grade fixed income securities with investments sourced and evaluated through bottom-up fundamental research. It aims to outperform the Barclays Global Aggregate Corporate Bond Index by 1.5% per year, gross of fees, within a tracking error range of 0-3%. The strategy seeks to exploit a global investment universe, with typical exposure consisting of 80-250 issuers, and is permitted to take positions off-index. The Fund can also take short positions by buying credit default swaps (CDS) protection on specific issuers. Due to its size, we view this fund as a more nimble "stock-picker" and hope that this attribute will benefit the strategy in the current market environment.

PIMCO Income Fund

This fund offers diversified exposure to fixed income markets, managed by PIMCO, the largest global bond manager. The portfolio is divided into two general sections. Firstly, higher yielding assets, which include corporate credit, mortgage backed securities and Emerging Market debt. These assets are expected to perform well during periods of robust economic growth. Secondly, higher quality assets, which currently consists mainly of government bonds in the US and Australia. These positions provide a balance to the portfolio, benefiting from periods of weaker economic growth or market turbulence. We have a high opinion of the management team and consider the strategy to have strong potential for long term outperformance over fixed income markets.
