FUND OBJECTIVE

The objective of this portfolio is to provide above average growth in capital over the medium to long term. Income will be of secondary importance. The risk associated with this portfolio shall be the same as the risk associated with SA equities as an asset class. Volatility of capital can occur over the short-term.

FUND STRATEGY

The portfolio shall invest in assets in liquid form and in securities across all sectors of the JSE Securities Exchange of South Africa as well as international exchanges and other permissible assets allowed by the Act. The portfolio shall be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time in order to achieve its investment objective, and shall be permitted to invest in offshore investments as legislation permits. This portfolio will invest predominantly in equities. Apart from the above, the portfolio may also invest in participatory interests of portfolios of collective investment schemes registered in the Republic of South Africa or of participatory interests in collective investment schemes.

The fund will be managed with a high conviction approach, typically holding no more than 20 positions at any time. In line with the investment manager's investment philosophy and process, the holdings will be concentrated in selected JSE Top 50 companies with the buy-to-hold management approach encouraging minimal portfolio turnover.

FUND COMMENTARY

During July 2020 the Fund initiated a direct holding in Capitec Bank Holdings Limited (Capitec). Capitec's earnings have increased tenfold over the last decade. Initially, growth was largely underpinned by the group's unsecured retail lending business. Today the business is significantly less dependent on retail lending as the primary driver of sustainable growth: lending activities now comprise 41% of operating income compared to 84% a decade ago. Transactional banking fees, funeral insurance and interest on fixed income and cash account for the remaining 59% of operating income. In addition, Capitec has been systematically improving the quality of its loan book over the last few years. Capitec now lends to 1.2 million clients out of its 14 million client base. Impressively, this transition has been managed whilst successfully retaining a high and stable return on equity of 25%-26%, and a very attractive operating efficiency. Recent results further illustrate the resilience that these high returns contribute to the business. For the year that ended February 2020, non-interest revenues increased 24% and earnings per share increased 18%, supported largely by the bank's transactional banking, credit card and funeral insurance products. Whilst returns declined at banks across the industry, Capitec's return on average equity rose to 26.4%. Transactional volumes are expected to hold up reasonably well in 2020, and were down only 7.1% in May despite level 4 lock down restrictions. We believe transactional banking revenue will remain resilient and continue to grow strongly in the 2021 financial year. Capitec is expected to continue expanding its 14 million strong customer base, cross selling products and adding new banking and insurance products to their valuable customer platform. The bank is using the current environment to further drive its mobile, cell phone and digital channels and appropriately control operating expenses. Loss reserves equivalent to 26% of gross loans reflect the uncertainty around the level of actual credit losses to be realised. Furthermore, the total yield on retail loans is made less certain during this period by Capitec assuming the risk for clients' credit insurance. Despite this, we expect attractive future returns well above the cost of capital. When reinvesting the majority of this as done in the past, the bank's ability to achieve compounding growth remains its most attractive feature.[†]
