### FUND OBJECTIVE

The objective of this portfolio is to provide above average growth in capital over the medium to long term. Income will be of secondary importance. The risk associated with this portfolio shall be the same as the risk associated with SA equities as an asset class. Volatility of capital can occur over the short-term.

### FUND STRATEGY

The portfolio shall invest in assets in liquid form and in securities across all sectors of the JSE Securities Exchange of South Africa as well as international exchanges and other permissible assets allowed by the Act. The portfolio shall be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time in order to achieve its investment objective, and shall be permitted to invest in offshore investments as legislation permits. This portfolio will invest predominantly in equities. Apart from the above, the portfolio may also invest in participatory interests of portfolios of collective investment schemes registered in the Republic of South Africa or of participatory interests in collective investment schemes.

The fund will be managed with a high conviction approach, typically holding no more than 20 positions at any time. In line with the investment manager's investment philosophy and process, the holdings will be concentrated in selected JSE Top 50 companies with the buy-to-hold management approach encouraging minimal portfolio turnover.

## FUND COMMENTARY

Richemont reported financial year end results in May. Sales and operating conditions for the final quarter of the financial year were significantly impacted by Covid 19 with sales down 18% for the period. Full year revenue increased by 2% with gross profits in line with the prior year. Reported profits were down 66%, with the prior year including a non cash gain of EUR1.4 billion on the consolidation of Yoox Net-a-Porter 'YNAP'. Cash flow from operations increased 16% to EUR2.4 billion with the group having EUR2.4 billion in net cash at year end. The group's online distribution platforms (YNAP, Watchfinder) grew sales by 15%, with losses accelerating to EUR241m on the back of continued investment, distribution centre closures as a result of Covid 19 and a competitive pricing environment. In light of the current uncertainty Richemont cut dividends by 50% and announced a potential equity based shareholder loyalty scheme (further detail to follow).

YNAP is the world's largest multibrand luxury retailer, with platforms that function both as a department store for a diverse selection of luxury goods as well as operating single-brand flagship online stores for a number of Richemont's luxury competitors. Online distribution platforms now account for 17% of Richemont group sales. Management remain committed to the strategy of investing in what they believe to be the future of growth in the luxury sector.

Richemont's key jewellery and watch Maisons are brands with over 100 years of heritage, established supply and distribution channels and highly skilled labour all creating a healthy competitive advantage. Online sales of luxury goods are expected to comprise 20-25% of the luxury sector by 2025 from 10% currently. The sector is currently evolving rapidly and competition remains elevated as industry players try to gain market share. Richemont's investment in their online platforms has come at a cost to current investor returns and raised the risk profile of the future growth strategy all of which has been factored into our updated Quality, Valuation, Risk and Conviction assessments.
