#### INVESTMENT OBJECTIVE

To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

#### INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

#### **FUND COMMENTARY**

The MSCI ACTR World equity index dropped by an astounding -9.6%\* over September. Barring the drop of -13.5%\* in March 2020 with the onset of the Pandemic, this is the largest calendar monthly drop since the Financial Crisis.

Most of the reasoning for this sharp reaction is due to the Federal Reserve (Fed), stating clearly during their 21 September meeting that they are committed to bring down US inflation to their long-standing target of 2%, and announcing their third consecutive 75 basis point (bps) hike in their target rate. As a result, the ten-year Treasury yield increased from 3.2% to 3.8% over the month, triggering huge volatility in the Bond market which rubbed off on Equities as well.

With other Central banks lagging in their rate hikes, the Dollar continued its relentless strengthening. It added another +3.1%\*\* over the month, bringing its total appreciation to +17.2%\*\* over the year thus far. The currency has become a damper on the US economy and a huge headwind for their globally diversified corporates which, in turn, also contributes to Equity volatility. The market is now very unforgiving under these circumstances, with the result that any disappointment with a business's operational performance gets severely punished, irrespective of its future potential.

The main fundamental issue remains the level of US inflation, and aligned with that, US interest rates. Consensus expectations for the September CPI reading is a further drop of -0.2% to +8.1%. Along with that, we perceive the Dollar now effectively fulfilling part of the Fed's task by cooling the US economy – and therefore moderating inflation. We won't be overly surprised if the next Fed meeting may deliver the last +75 bps hike for the current cycle, and that market volatility can start calming. In the interim, we continue to make sure we hold the best franchises that may again attract investor interest for their quality characteristics.


