INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund (“Master Fund”), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Contrary to historic patterns, September delivered a positive stock market return. This follows a positive second quarter S&P 500 earnings season, US headline inflation dropping sharply to 2.5% and the 10-year Treasury yield sliding further to 3.8%. Investors are intensely focused on US employment data with new employment numbers staying relatively healthy (close to the long-term average of 127,000), but below expectations. Employment data is causing some concerns about a potentially weakening economy, with investor focus having shifted firmly from inflation uncertainties to economic growth reservations.

The overriding global event of the month was the bold stimulus package from China’s central bank to boost their ailing economy. It cut some interest rates to support the housing market and injected \$143 billion into the banking system by cutting reserve requirements. It further provided \$114 billion of liquidity for listed firms to buy back shares and facilities for institutional investors to borrow funds easily for these purposes. The Central Bank also indicated that this package may be followed by more support later on. Despite the fact that this is monetary rather than direct fiscal support, the market responded favourably with the CSI 300 mainland index rising by almost 20% over the month. We perceive this as an important global capital market event with a growing possibility of international investors to reconsider China.

The best contributors to fund performance during the month were Amazon, Zoetis and Microsoft, all growing off a low base in August. LVMH made a strong recovery, reacting on the above positive news on China. The largest detractors were Adobe, ASML and AJ Gallagher. Adobe’s results exceeded expectations, but their Digital Media outlook disappointed marginally. ASML was affected by Intel – a major client of theirs – reporting weak results and restructuring plans. Despite solid results, AJ Gallagher took a breather after a strong run over the preceding four months.

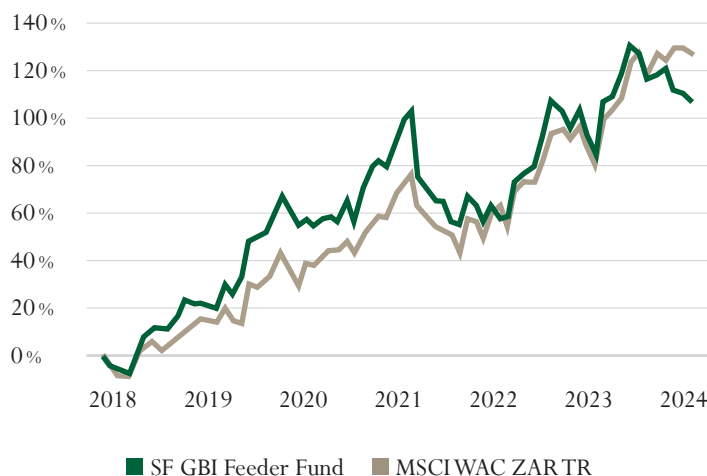
