The Fund is managed by Link Fund Manager Solutions (Ireland) Limited.

### Objectives and Investment Policy

The Fund aims to achieve long term growth in capital and income by developing a portfolio of equities and equity related instruments issued by or in connection with high quality listed companies from around the world.

The Fund intends to invest predominantly in equity and equity related securities issued by or in connection with high quality larger capitalisation companies.

Subject to the Fund's objective, policies and investment powers, the Investment Manager is allowed to make discretionary choices when deciding which investments should be held in the Fund.

#### Essential features of the Fund:

The Fund has the discretion to invest in a range of investments as described above.

The Fund has no specific target market or geographic sector.

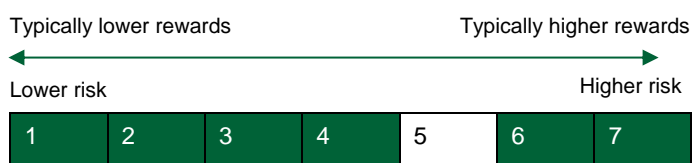
The Fund is considered to be actively managed in reference to MSCI World All Countries TR (the "Comparative Index") by virtue of the fact that it uses the Comparative Index for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Comparative Index. However the Comparative Index is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Comparative Index.

You can buy and sell shares in the Fund on each business day.

The class of the Fund distributes income.

Derivatives may be used for efficient portfolio management and to manage the risk profile of the Fund.

### Risk and reward profile



This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free.

The Fund has been classed as 5 because its volatility has been estimated as above average. The classification is based on actual Fund returns and estimated historical data of a relevant benchmark and may not be a reliable indicator of the future risk profile of the Fund.

The value of equity securities varies with the performance of the respective issuers and movements in equity markets generally. As a result, the Fund may suffer losses if it invests in equity of issuers where performance falls below market expectations or if equity markets in general decline or the Fund has not hedged against such a general decline.

The Fund may hold a relatively small number of stocks (approximately 20 to 30 positions) as compared to many other funds. This may make the Fund's performance more volatile than would be the case if it had a more diversified investment portfolio.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

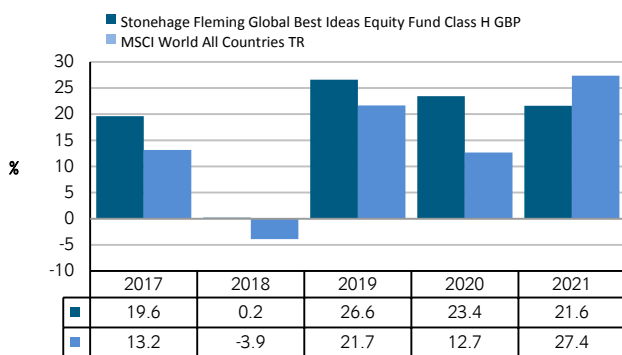
The Ongoing Charges Figure may vary from year to year.

You may also be charged an anti-dilution levy on entry to or exit from the Fund. This will only be applied to net subscriptions or redemptions exceeding 3% of the NAV of the Fund.
