PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned -4.5% in January.

Global equities declined sharply at the start of the year, led by US technology stocks and other high growth sectors. The prospect of persistent inflation and faster interest rate hikes by central banks motivated investors to rotate away from the winners of last year and into more cyclical areas of the market. Energy, financials and materials did particularly well as the oil price continued to surge and bond yields moved higher.

Against this backdrop our core allocation to long term structural growth themes within the equity component came under pressure, with Stonehage Fleming Global Best Ideas and Driehaus US Small Cap strategies the two largest detractors. Despite recent volatility, these strategies offer exposure to high growth themes such as disruptive technology, innovative healthcare solutions and consumer trends, across the market capitalization spectrum, which we continue to have conviction in over the coming years. Elsewhere, we benefited from a bias to the UK, with the GLG Undervalued Assets fund delivering positive returns in a negative market environment. This strategy emphasises recovery ideas in the UK and thrives when investors favour low-valuation areas of the market. Our allocation to commodities remains a valuable diversifier, rising on higher inflationary pressures and geopolitical tensions, and added positive returns to the portfolio last month.

The portfolio continues to be well diversified across cash, bonds, equities and alternative assets and, whilst further bouts of volatility will not come as a surprise over the short term, we retain a constructive view on the prognosis for risk assets over the longer term.
