

PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned +0.7% in January

After rallying in Q4, global equities delivered moderate gains in January, with strong performance from US and Japanese equities offset by declines in Asia and the UK. Strong US economic data supported sentiment but caused investors to lower expectations of early interest rate cuts. Technology was the best-performing sector, driven by US mega caps, whilst smaller companies and the more rate-sensitive sectors underperformed. Tighter credit spreads limited losses in Fixed Income as government bond yields rose, whilst Energy performed well within Commodities as geopolitical tensions remained high.

Within equities, strong performance from the SF Global Best Ideas fund (GBI) and US manager Driehaus offset weakness from smaller cap and international managers Dimensional and Veritas. The UK sovereign bond allocation declined, whilst Pimco Income outperformed its benchmark due to a lower duration positioning. 3i Infrastructure and Blackrock APAC Absolute Return both delivered market-beating returns within Alternatives, but the Gold position fell as the dollar strengthened.
