To preserve capital in the medium term and to achieve capital growth in real terms over the longer term, whilst generating moderate levels of income.

PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned +2.1% in June, taking 2024 returns to +6.2% so far.

The US economy showed signs of a moderate slowdown whilst inflation came in below expectations. The labour market continues to cool with the unemployment rate reaching 4.1%, although employment levels remain robust. Europe's improved industrial production and economic sentiment, along with declining inflation, led to a European Central Bank rate cut. Large companies in the developed equities markets performed well in June while rate sensitive small cap stocks suffered from confirmation of the higher for longer interest rate environment. Fixed income remained flat for the month, with the Bloomberg Global Aggregate Index returning slightly less than 1%.

Driehaus, our small cap growth manager holding, continued to outperform its benchmark benefitting from strong stock selection. Similarly, the Veritas Asia fund posted strong returns on the back of emerging opportunities outside of China, while Sector Healthcare recovered some performance, driven by pharmaceutical and biotechnology investments. Sovereign bond holdings positively contributed to performance after rates fell in the US and UK. Our Long/Short managers added value from successful long and short positions, with particularly good attribution to Asia.


