

PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned +3.3% in October, taking 2025 returns to +10.2% so far.

In October, despite continued uncertainties around geopolitical tensions, fiscal pressure and the US government shutdown, global growth remained steady, supported by resilient private sector activity and stable consumption in advanced economies.

US equities had a strong month, led by continued strength in the technology sector. European equities underperformed, weighed down by mixed earnings results and a cautious ECB tone. Emerging markets also performed strongly driven by robust performance in Asia. Fixed income markets broadly rallied, as investors rotated into duration and credit following the Fed's rate cut. The US Treasury curve remained broadly flat, while credit markets benefitted from risk-on sentiment and a strong demand for carry. Gold's price surged to an all-time high mid-October, before a sharp correction in the second half of the month. The US dollar, which had recovered over Q3, continued to appreciate in October versus most global currencies.

Strategies like Driehaus and Veritas outperformed their benchmark, benefitting from good stock selection and strong Asian equity markets, while Jupiter and Polar lagged their benchmark. Reaching another all-time high, Gold delivered strong positive returns over October.






CURRENCY ALLOCATION
