#### PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned +2.5% in September, taking 2025 returns to +6.7% so far.

US stocks climbed in September, with tech heavy indices rising sharply as mega-cap tech names rebounded following major Al infrastructure announcements. European equities posted modest gains, through political uncertainty in France and tariff tensions continued to weigh on investor confidence. Emerging markets advanced, aided by a weaker US dollar and signs of stabilisation in China's economy, particularly in tech and consumer sectors. Broader sentiment improved after the Federal Reserve delivered a widely anticipated rate cut, with guidance suggesting further easing ahead. Fixed income markets saw mixed performance amid shifting rate expectations and persistent inflation concerns. In the UK gilt yields rose, as inflation remains sticky.

Global equities extended gains in September, supported by resilient corporate earnings and renewed optimism around artificial intelligence. Strategies like Driehaus and Veritas significantly outperformed, benefitting from strong stock selection in Pharma and Tech-exposed names, while Global Best Ideas and GMO Quality lagged their benchmark.






