PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned 3.1% in January.

January 2025 was marked by the return of Donald Trump to the White House and his pro-America political agenda along with him. US employment data was stronger than expected with the unemployment rate falling to 4.1% while inflation rose to 2.9% from 2.7% in the previous month. This led to expectations of sustained high interest rates, influencing the global bond markets. Inflation unexpectedly rose in Europe driven by energy prices, remaining above the European Central Bank's 2% target, however interest rates were still cut as expected. The UK economy continued to soften in January while inflation nudged down to 2.5%, in line with expectations.

The equity portfolio finished in-line with global markets. Notable outperformers included holdings less exposed to the AI theme; Veritas Asia beat its benchmark following strong allocation to Industrials and Financials. Similarly, the strategy also benefitted from less aggressive tariff threats from the US as its China holdings, such as Alibaba, were strong contributors for the month. Elsewhere, Sector Healthcare finished in line with its benchmark, with the sector enjoying a strong month, benefitting from solid fundamentals and pipeline developments. Fixed income markets generally got off to a positive start for the year, corporate bond benchmarks posted positive returns, especially in Europe thanks to tighter corporate spreads, while government bond indices were more mixed. Gold and other metal prices rose on the back of Trump's tariff threats, while oil prices were lifted by cold winter weather and US sanctions on Russia.






ASSET ALLOCATION
