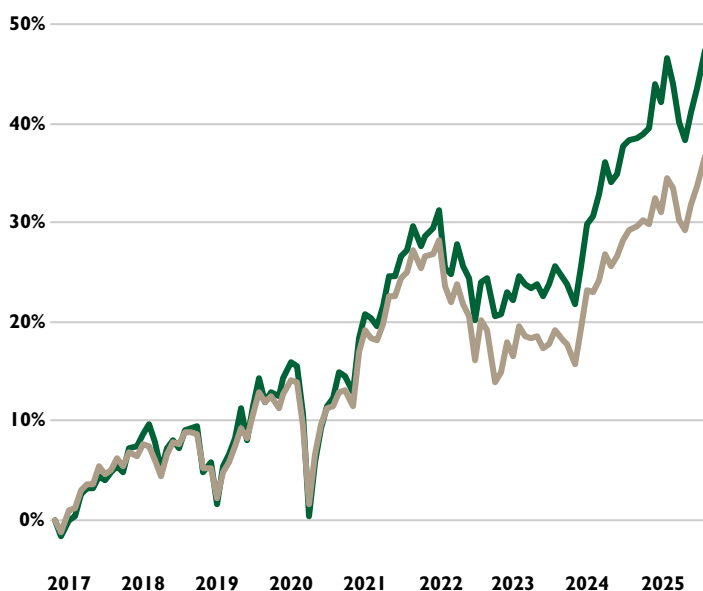

PORTFOLIO COMMENTARY

Economic data from the US and Eurozone showed resilience in July despite global uncertainty. US GDP beat expectations, PMI remained expansionary at 52.9, and inflation rose to 2.7%. The labour market stayed broadly healthy, though signs of softening emerged. Eurozone GDP grew just 0.1% quarter-on-quarter, with inflation steady at 2.0%. Global equities rallied on strong US earnings and new trade deals, while European stocks faced 2026 growth concerns. Emerging markets advanced, led by Taiwan's AI momentum. Bond yields rose modestly across developed markets, oil rebounded on tighter supply, and gold held near \$3,300.

The equity portfolio posted a negative return, mainly due to sector allocations in healthcare and insurance, and regional exposure to emerging markets. In contrast, the S&P 500 was the strongest contributor. Fixed income holdings offset equity weakness, with positive contributions from the PIMCO Income strategy and UK Gilts. No changes were made to portfolio positioning during the period.

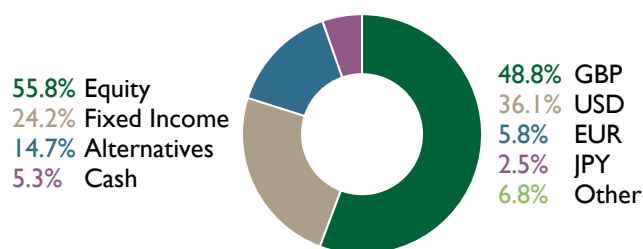

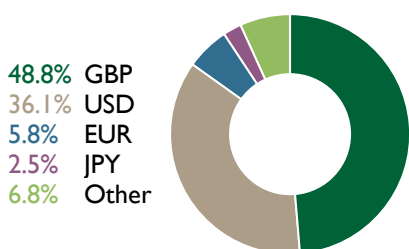

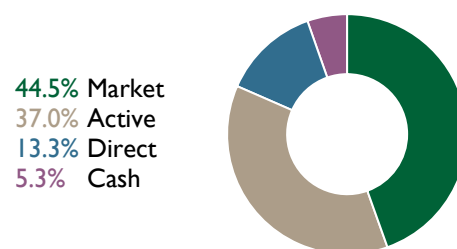
