

To preserve capital in the medium term and to achieve capital growth in real terms over the longer term, whilst generating moderate levels of income.

#### PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned +2.5% in March, taking 2024 returns to +4.9% so far.

Stronger than expected economic data and inflation print pushed yields up 0.3% during the first quarter as the market continues to monitor the Fed for rate cuts. Global equities recorded their best first quarter since 2019 as investors remained optimistic for a soft landing and AI drove technology company earnings. Returns were also strong for Japanese and European equities, the latter propelled by obesity drugs manufacturers and financials. Chinese equities recovered, helped by government stimulus.

Within equities, small cap manager Driehaus benefitted from holdings in technology, consumer and industrial stocks, whilst Polar Insurance also outperformed global markets as their Property & Casualty insurance holdings saw positive earnings results. Stonehage Fleming Global Best Ideas underperformed as, despite good returns from AI-related stocks, several large holdings disappointed on earnings dragging down the performance of the fund. Fixed income positions were challenged by rising yields across major economies.


