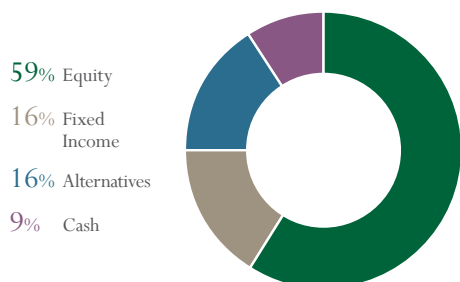

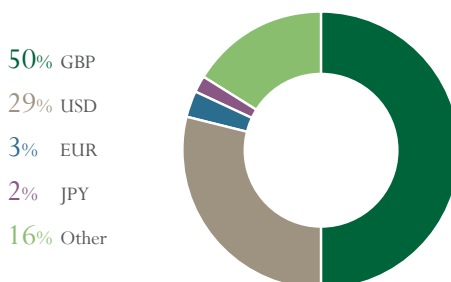

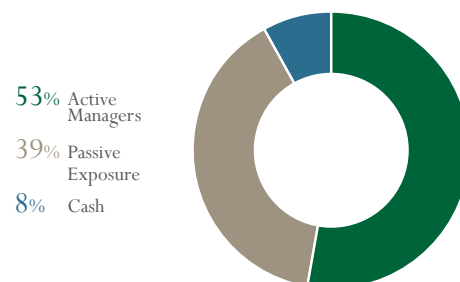
ASSET ALLOCATION

PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned -1.0% in May, taking 2022 returns so far to -5.2%.

May was a volatile month for global equities as concerns around inflation and tightening monetary policy drove markets to new lows before staging a recovery towards the end of the month. From a sector perspective, Energy continued to outperform, whilst Consumer Staples reverted having previously outperformed due to its defensive properties. There was little dispersion between regions, with Japan and the UK marginally outperforming most others given their value tilt. Fixed income broadly continued to be impacted by uncertainty, and elevated rate hike expectations and inflation prints, although growth concerns slightly moderated hawkishness. In credit, spreads widened for much of the month but broadly pulled back strongly towards the end. Lower rated credit generally underperformed higher quality issuers, which has been less common this year. Commodities continued to rise in aggregate, with energy and agricultural sectors outperforming amid the Russia-Ukraine war, but metals trailing given higher rates and growth concerns.

Companies which trade at competitive valuations led markets in most regions, which translated into our value-oriented managers, such as SF European All Cap, Man GLG Undervalued and Lyrical, outperforming. Our allocation to managers focused on growth/quality detracted, with Artisan and Driehaus struggling. Although exposure to broad commodities performed well, further weakness came from our gold allocation amid record inflation prints and higher rates.
