#### PORTFOLIO COMMENTARY

# The Global Growth Portfolio returned -0.6% in March, taking 2023 returns to 1.4%.

Concerns over the stability of the global banking system and the collapse of SVB and Credit Suisse dominated market moves in the month. Growth and quality names strongly outperformed value amid Financials falling out of favour. Large caps performed better than small and mid-sized companies as investors turned to quality. The UK underperformed given its value tilt and larger weighting in banks. Within fixed income, falling yields helped offset spread widening.

Gold was the top performer as investors sought out safe haven assets, and our quality/growth manager, Stonehage Fleming Global Best Ideas, also outperformed against this backdrop. It was a difficult month for GLG Undervalued and Dimensional given their focus on smaller, value companies.

We introduced listed infrastructure exposure in the month by adding 3i Infrastructure, which has a strong track record and provides yield and diversification benefits.
