

PORTFOLIO COMMENTARY

The Global Growth Portfolio returned +0.05% in November, taking 2025 returns to +11.11% so far.

Equities were broadly unchanged in November, with the MSCI World index and US equities ending the month roughly flat. Market activity was muted, as earlier gains in Al-related tech stocks stabilised and investors showed a preference for defensive sectors. European equities outperformed, supported by increased defence spending and hopes of fiscal expansion. In fixed income, policy divergence was evident as markets priced in rate cuts for the UK and US, while expecting stability in the Eurozone. The dollar lost momentum in late November as markets shifted decisively toward expecting Fed easing in December.

GMO Quality and Sector Healthcare were notable positive contributors, along with the S&P 500 equal weighted tracker, which benefitted from the rotation into defensive sectors. Gold extended its rally following October's correction, continuing to be a key driver of performance.





ASSET ALLOCATION




