

PORTFOLIO COMMENTARY

The Global Growth Portfolio returned -0.4% in September, taking year to date returns to 2.4%.

September was a challenging month for capital markets. Equities and bonds both fell as the Federal Reserve signalled rates will be 'higher for longer' to keep inflation under control. Within equity markets, Energy and Emerging Markets outperformed as sentiment around China improved amid signs the economy is bottoming out. Fixed income markets fell as the US 10 year yield reached a 16-year high. Credit held up better, with High Yield the best performing category.

It was a difficult month for the active managers, particularly the Stonehage Fleming Global Best Ideas Fund (GBI), which faced headwinds from consumer and financials stocks, LVMH and Visa. One bright spot was GLG in the UK market, which outperformed on strong stock selection within Consumer Discretionary. The Xtrackers Energy ETF also performed well amid rising oil prices. Within fixed income, a steepening of the UK yield curve boosted the shorter-term UK Gilt position; but this was offset by declines in the US Treasury ETF, with the asset class down overall in the month. Commodities delivered positive returns, led by the iShares Commodity ETF and its oil and gas exposure.


