

# PORTFOLIO MANAGER PERFORMANCE



#### PORTFOLIO COMMENTARY

The Global Growth Portfolio returned -2.1% in April, taking 2025 returns to -4.5% so far.

The US economy continued to show signs of moderation, with Q1 GDP quarter-on-quarter growth declining to -0.3%, falling below expectations. Despite this, the labour market remained stable, with the unemployment rate still hovering near historic lows. In Europe, the recovery showed signs of fragility as demand weakened and the service sector stagnated in April. European inflation continued its downward trend, prompting the European Central Bank to cut interest rates by another 0.25% during the month.

While global markets managed a modest positive return in April, the period was characterised by severe volatility as investors digested the implications of President Trump's tariff announcement. The equity portfolio was up in absolute terms, but was slightly behind global markets in relative terms. Despite a challenging start to the year, our small cap strategy, Driehaus, enjoyed a stronger month as positive price action supported a number of its holdings. Polar Insurance endured a challenging month as its underweight to European insurers was a headwind, while Sector Healthcare lagged its benchmark following continued regulatory uncertainty. Fixed income indices posted positive returns, as core government yields ended lower and underlying income offset credit spread widening.


