PORTFOLIO COMMENTARY

The Global Growth Portfolio returned 0.4% in August, taking 2022 returns so far to -6.5%.

Global markets faced a challenging backdrop in August as the US central bank made it clear that it will prioritise bringing inflation under control even if there is short-term pain to the economy. Energy was the only sector to deliver positive absolute returns. Regionally, emerging markets led, whilst UK and Continental Europe performed poorly. Bond yields rose, leading to further losses for bond holders, whilst the broad commodity complex performed well driven by natural gas.

The portfolio outperformed in the month. Driehaus had a strong month with US small caps performing well, as well as good stock selection within Technology. Veritas Asian and our passive exposure to EM equities were notable contributors. The alternatives book had a good month overall, with only Sandler posting negative returns. Key detractors were our allocations to UK and US shorter dated sovereigns amid rising rates, and our sterling hedged S&P 500 exposure also struggled given the Fed hawkishness.
