PORTFOLIO COMMENTARY

The Global Growth Portfolio returned in -0.1% August, taking 2024 returns to 7.8% so far.

Inflationary pressures continued to ease in August, while the labour market remained robust, with low unemployment rates and moderating wage growth. There were continued signs of weakness in manufacturing, which added to the uncertainty. Jerome Powell, the Chair of the Federal Reserve, stated that the economy was now ready for lower interest rates, raising expectations that the cutting cycle would begin in September.

The equity portfolio posted positive returns and we saw particularly strong returns from our specialist managers; Polar Global Insurance and Sector Healthcare Value, which both tend to offer more defensive earnings streams. Smaller companies underperformed their regions, which included Dimensional Global Targeted Value and Driehaus US Small Cap. In Fixed Income, PIMCO Income had another positive month, benefitting from stable credit markets and falling bond yields.
