PORTFOLIO COMMENTARY

The Global Growth Portfolio returned -1.2% in December, taking 2024 returns to 12.1%.

In December, the US economy remained robust and the labour market continued to cool. The Federal Reserve cut interest rates by 0.25% in early December, but sticky inflation prompted Chair Jerome Powell to guide for fewer rate cuts in 2025, dampening investor confidence later in the month.

Consequently, the US equity markets had a weaker month as investors negatively reacted to the hawkish outlook from the Fed. Our US small cap strategy, Driehaus, which benefitted from strong stock selection in manufacturing and health tech, but pulled back materially in December as the rise in long-term treasury yields pressured the broader small cap market. Regionally, Veritas Asia remained in-line with its benchmark following strong stock selection in technology, but the prospects of heightened trade tensions continued to weigh on the region. Sector Healthcare outperformed its benchmark, largely benefitting from not holding Novo Nordisk while Stonehage Fleming Global Best Ideas remained in line with its benchmark, primarily driven by strong selection in Google and Edwards Lifesciences. December also proved to be challenging for fixed income markets, as core sovereign bonds saw yields increase on the back of a reversal in the market's expectations of future central bank rate cuts.






ASSET ALLOCATION
