#### PORTFOLIO COMMENTARY

The Global Growth Portfolio returned -0.7% in February, taking returns in 2022 so far to -6.1%. Russian military action in Ukraine drove sharp market moves in late February with global equities ending the month at -2.2%. Commodities surged on the prospect of further supply disruption, particularly core Russian exports such as natural gas, oil and wheat. Government bonds provided only temporary relief for investors, with bond yields ending the month higher as inflation concerns dominated.

As market volatility rose in this highly uncertain period our core allocations to risk assets, such as equities and credit, suffered negative returns. However the overall portfolio proved resilient with a number of positions working well. In particular, our allocations to commodities, which we introduced to the portfolio in early 2020 through an initial investment in physical gold and extended with a broader allocation to commodities last year. We added to our physical gold holding, which ended the month at 4.7% of the portfolio, and trimmed our broader commodities allocation as prices surged later in the month. We also exited our dedicated Emerging Market local currency Debt position in early February, identifying potential headwinds for EM currencies on rising inflation and geopolitical risks.

Whilst the Russian invasion of Ukraine has quite rightly taken center stage as the driver of investment markets in the short term, we continue to focus on our disciplined long term approach which supports a constructive allocation towards equities and credit. The economic and investment implications of these events remain highly uncertain, and we are vigilant to further escalation and the consequences for inflation, policy and market levels.
