### Product

The Fund is managed by Carne Global Fund Managers (Ireland) Limited (the "Manager") which is authorised in Ireland and regulated by the Central Bank of Ireland. Stonehage Fleming Investment Management Limited (the "Investment Manager") has been appointed as investment manager to the Fund.

### What is this product?

**Type:** The Fund is domiciled in Ireland and is an open-ended investment company ("OEIC") and qualifies as an undertaking for collective investment in transferable securities ("UCITS").

**Intended retail investor:** The Fund is suitable for investors seeking long term capital appreciation and capital preservation with an initial subscription of GBP 35,000.

**Term:** This Fund has no maturity date.

### Objectives:

The Fund aims to preserve capital in the medium term and to achieve capital growth in real terms over the longer term.

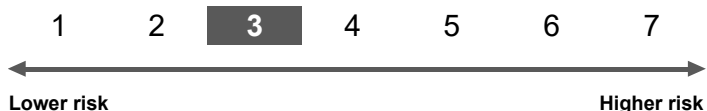
The Fund intends to invest predominantly in a range of underlying collective investment schemes which will provide exposure to a portfolio of assets comprising mostly global equities and equity related securities, cash and high grade bonds. They may also provide exposure to other elements, including, non-investment grade debt, commodities, infrastructure and property exposure. Subject to the Fund's objective, policies and investment powers, the Investment Manager is allowed to make discretionary choices when deciding which investments should be held in the Fund. The Fund has no specific target market or geographic sector.

The Fund performance will be measured against the Morningstar USD Moderate Allocation Category Average (the "Benchmark").

The Fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

## What are the risks and what could I get in return?

### Risk indicator

### What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?

The assets and liabilities of the Fund are segregated from those of the PRIIP Manufacturer. The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. In the event of the insolvency of the Depositary, you may suffer financial loss. There is no compensation or guarantee scheme in place which may offset, all or any of, your loss.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Fund's capacity to pay you.

**Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

### Costs over time
