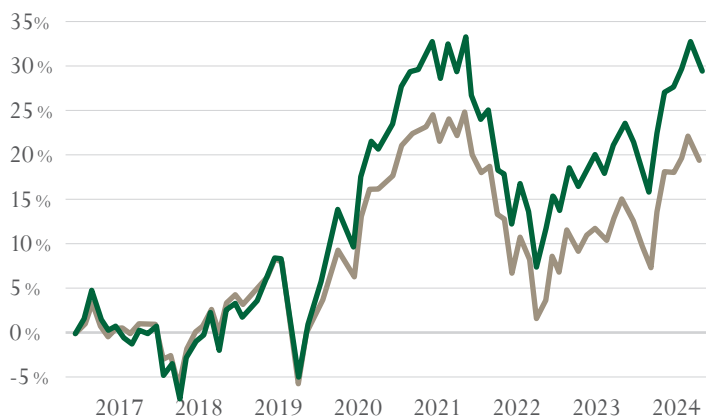

## PORTFOLIO COMMENTARY

**The Global Multi-Asset Portfolio A USD Class returned -2.2% in April vs -2.0% for the benchmark.**

Equity markets softened during the month following a strong start to the year, as rising bond yields weighed on investor sentiment. Credit spreads remain tight, reflecting robust economic conditions and longer-term market momentum. Despite a weaker-than-expected headline GDP print, underlying data revealed continued strength in the US consumer. This, coupled with stubbornly high inflation figures, postponed the timing of lower interest rates. This dampened investor sentiment, with both equity and fixed income markets experiencing losses.

The equity book posted negative returns but was ahead of broader equity markets. We saw good returns from our holdings in the UK, and Asian markets saw a resurgence, amidst policy developments and stock market support from China. This aided Veritas through their holdings in Chinese consumer stocks. The fund also benefited from its overweight exposure to Energy. Elsewhere, our more mid- and small-cap orientated strategies, Dimensional Global Targeted Value and Driehaus US Small-Cap Growth, underperformed.

The longer duration positions in US Treasuries in the fixed income portfolio underperformed in the rising yield environment.

Within alternatives, it was another strong month for gold and all holdings outperformed the broader hedge fund industry.

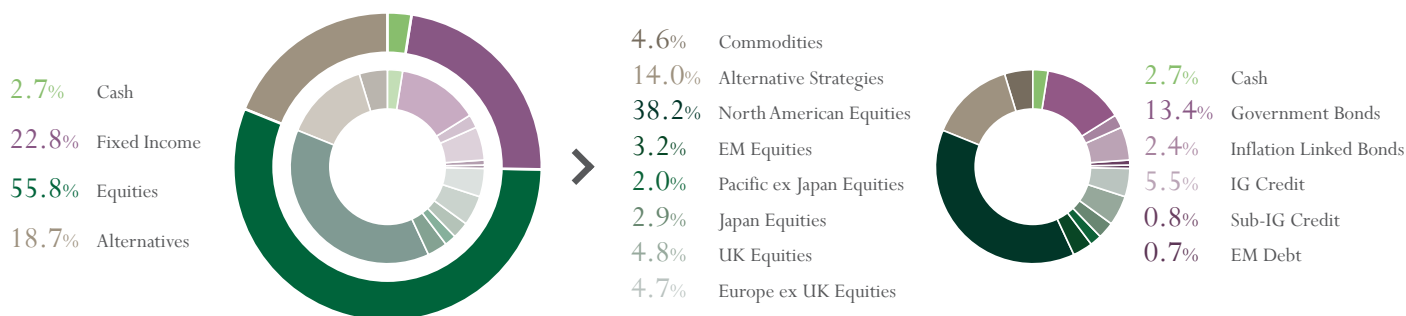
