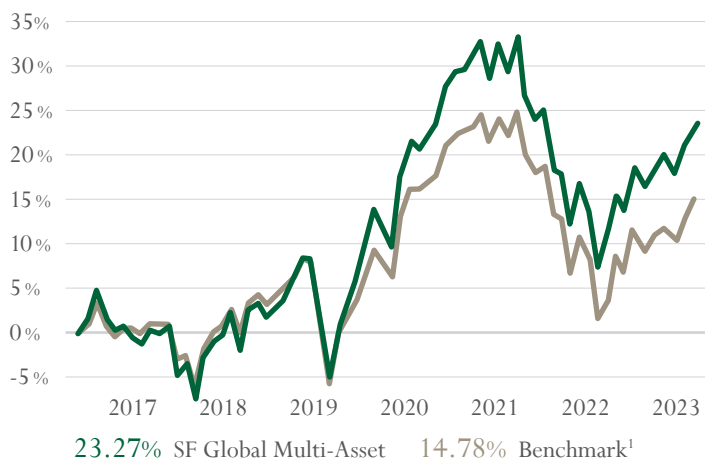

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio A USD Class returned 1.8% in July vs 2.0% for the benchmark. Global equities continued their upward trend in July as inflation fell further in the developed world and GDP data positively surprised in the US. Investors are increasingly optimistic that the Federal Reserve is close to the end of its tightening cycle, and with growth remaining resilient, a 'soft landing' can be achieved. Moves within equity markets reflected this improvement in risk appetite, with emerging markets and more economically sensitive sectors performing strongly, whilst more defensive sectors (e.g. healthcare and utilities) failed to keep up.

The equity book delivered positive absolute returns and delivered returns marginally behind broader equity markets. Our bias to small and medium sized companies was beneficial with strategies such as Dimensional Global Targeted Value and Driehaus US Small Cap doing well versus their regions; the former saw particularly strong performance from their holdings in US regional banks. It was also a good month for our active Value strategies in the UK and Europe, which saw areas like house builders and engineering firms performing well. It was a more difficult month in relative terms for holdings which are either more defensive in nature or positioned more defensively today – these include Stonehage Fleming Global Best Ideas (GBI), Polar Insurance, Sector Healthcare, Artisan US Focus and Prusik Asia Equity Income.

Within fixed income, credit outperformed aggregate benchmarks as market sentiment improved, particularly within the higher yield segment, whilst sovereign bonds lagged. The fixed income book was marginally ahead of broader fixed income markets driven by good performances from PIMCO Income and Bluebay Global Investment Grade.

It was a mixed month for the Alternatives book although it was positive in aggregate. Weaker performance from Lxyor/Sandler US Equity Fund was more than offset by better performances from GAM Star Cat Bond and our holding in gold.

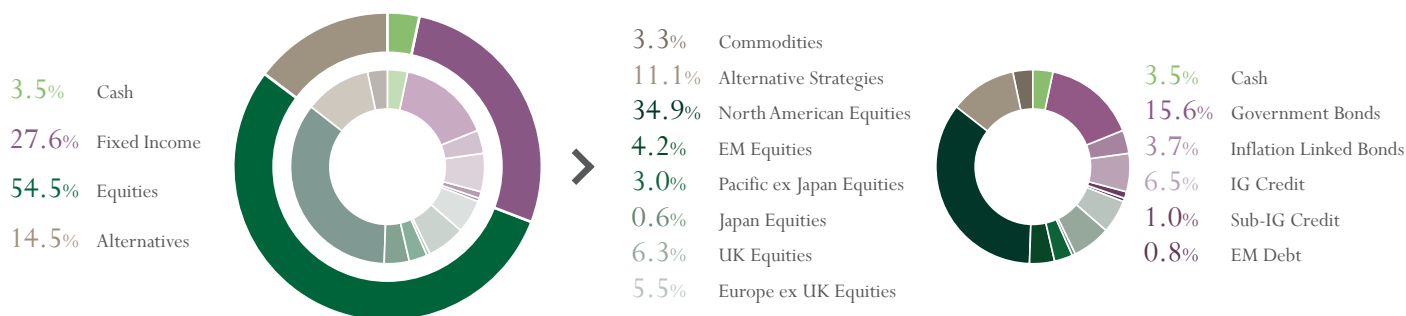
