



PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio A USD Class returned 0.8% in March versus 0.6% for the benchmark. Global equities returned 2.2% during the month whilst global fixed income assets fell as yields rallied sharply, returning -2.3%. Asset allocation contributed positively to performance given our underweight exposure to fixed income and overweight exposure to equities.

We benefited from our sector exposure within equities due to our specific allocations to insurance and healthcare, which outperformed. Some of our US equity managers had a difficult month, as Lyrical, Driehaus, Edgewood and Findlay Park all underperformed despite their differing styles.

The fixed income portfolio performed well relative to the global bond index, driven by our positions in PIMCO Income and iShares China CNY Bond ETF.

Our alternatives portfolio also outperformed, with both Marshall Wace ESG Market Neutral TOPS and our gold position having a good month.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
