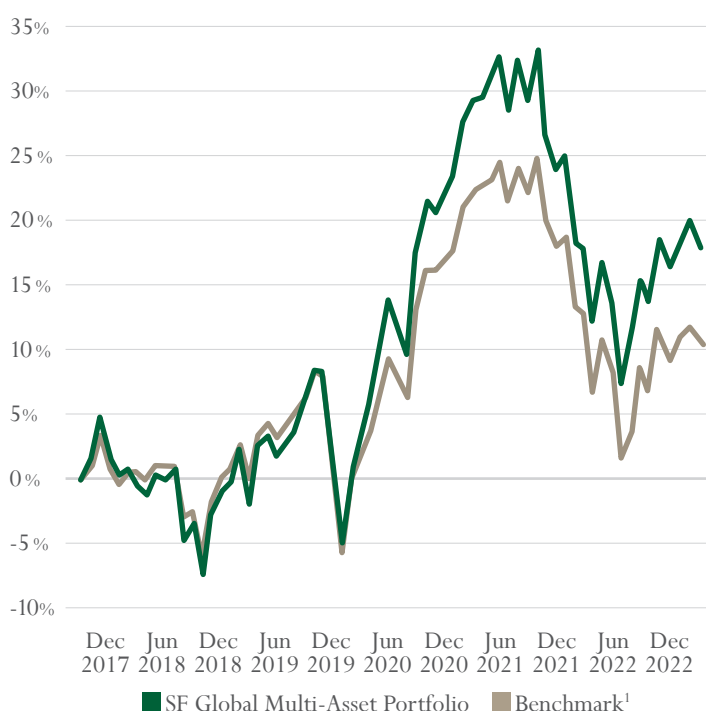

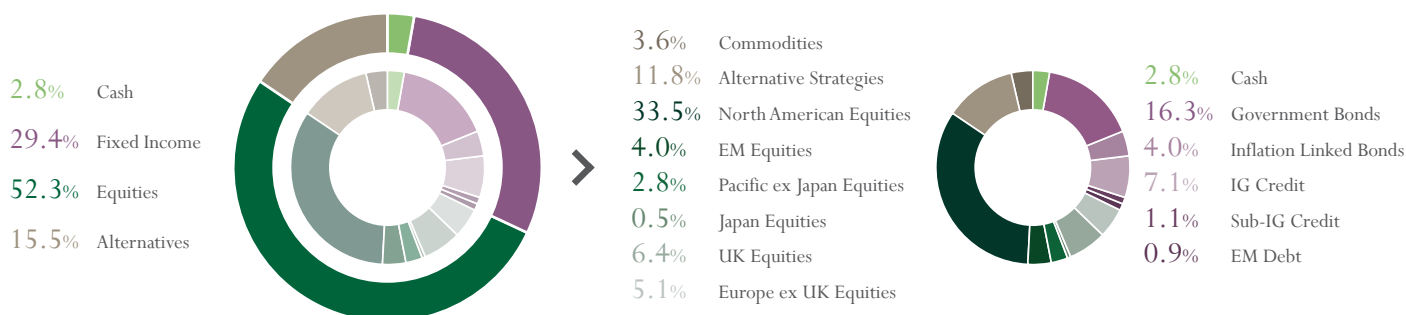
TRISTAN DOLPHIN, CFA

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio A USD Class returned -1.5% in May vs -1.0% for the benchmark. Global equity markets fell during May as US debt ceiling discussions dominated media headlines and global economic data remained mixed – resilient services sectors contrasting with weaker data in manufacturing. Leadership within equity markets was particularly narrow with the largest companies in the world, mostly within the US technology sector, significantly outperforming the average stock. As a result of this technology leadership, US equities outperformed the global index whilst UK and European markets, with their bias towards more defensive sectors and Energy, lagged.

The equity book trailed global equity markets in aggregate. The most significant headwind in the month was our lower allocation to mega cap companies, whilst underweight exposure to Semiconductors and Technology hardware also detracted. Regional allocation was a negative due to having no dedicated exposure to Japan where equity markets were particularly strong. Our thematic strategies in healthcare and insurance both underperformed as defensive areas of the market struggled. Although it was a difficult month overall, one bright spot was the better performance from our small cap Growth manager, Driehaus, which benefitted from holdings in smaller semiconductor companies such as Rambus and Axcelis Technologies.

Fixed income markets posted negative returns in the month as yields on core government bonds climbed higher. Core inflation remains stubbornly high in Europe and the UK, whilst in the US, a resilient labour market is fueling concerns that the Fed may be further from ending its rate hiking cycle. Our Fixed Income book underperformed as our more US centric mix of fixed income securities underperformed as yields climbed to a greater degree versus a more global mix.

Our Alternative book continued to perform well with our two long/short strategies and catastrophe bond position delivering positive returns. Gold was marginally lower.
