

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio A USD Class returned 4.1% in November vs 4.4% for the benchmark. Global equity markets continued to recover in November on the back of lower than expected US inflation data. Emerging markets were the standout performer and were aided by a weaker US dollar and speculation that China was starting to relax its zero-COVID policy. US equities were the notable laggard following the depreciation in the US dollar and a number of the larger constituents struggling – Apple, Amazon and Tesla. Sector moves for the most part reflected the changes in risk sentiment with defensive areas like healthcare and non-life insurance not rising as much, whilst commodities (excluding energy) and semiconductors performed well.

The equity book trailed global equity markets in aggregate, which was partly due to negative impacts from ETF month end timing. Our emerging market, UK and European exposure delivered the highest absolute returns in the month. Of particular note was Fidelity who saw strong performances from some of their consumer names (China Mengniu and Li Ning) as well as a recovery in some their commodity stocks (First Quantum Minerals). JO Hambro, our European manager, also had a good month after a difficult third quarter. A number of their industrial holdings (Rolls Royce, Wartsila) and also some of their technology holdings (Meyer Berger, Infineon) delivered good returns. Our US strategies trailed global equity markets as did our more defensive strategies, such as Sector Healthcare.

Within Fixed Income, it was a good month in absolute terms with rates fallings and credit spreads tightening. Our best performers in the month were PIMCO Income and Bluebay Global Investment Grade. Most of our holdings within the Alternatives book delivered positive absolute returns in November. Gold was the standout contributor and helped by a weaker US dollar.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
