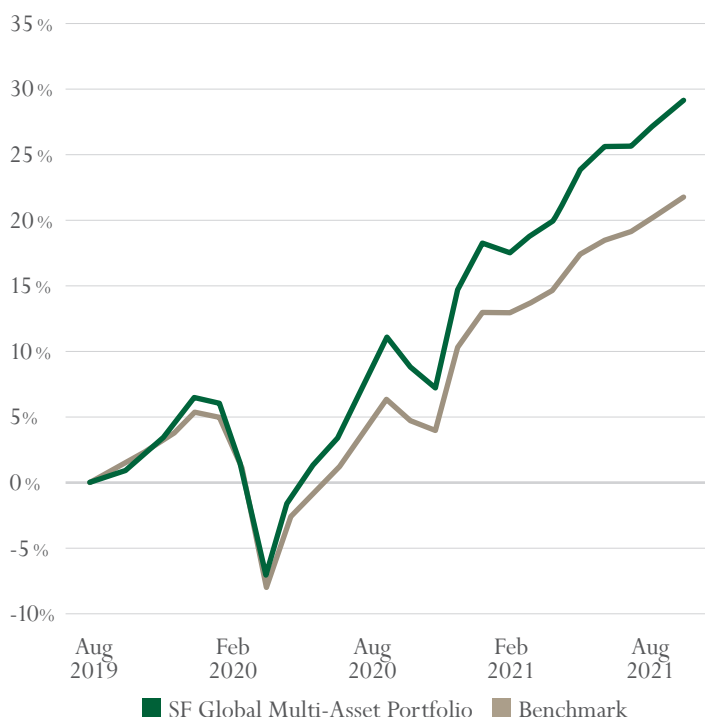

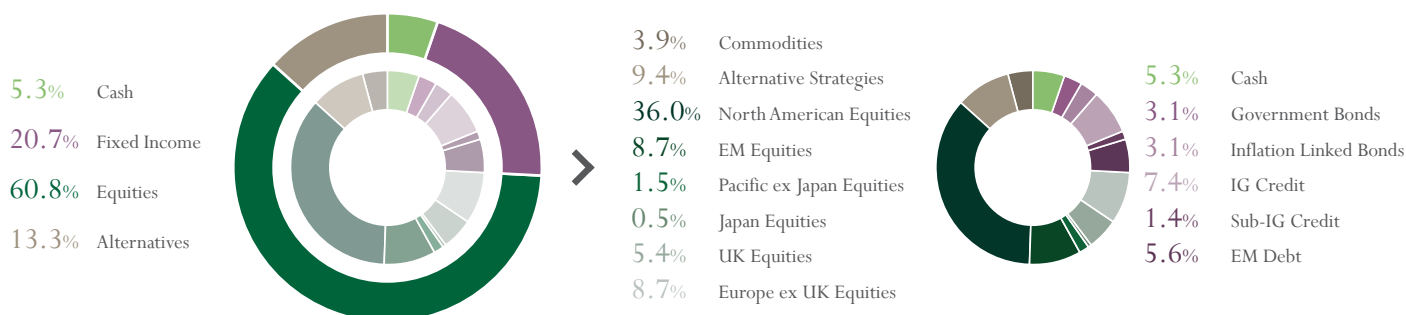
### HELEN LORING

## PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B Class returned 1.3% in August versus 1.0% for the benchmark. Global equities rose during the month as easing restrictions and economic recovery in developed markets remained supportive, although rising cases of the delta variant moderated sentiment somewhat as well as concerns over economic growth peaking. Global fixed income assets returned -0.2% as longer-dated government bond yields rose in the month.

Within equities, growth outperformed amid investors viewing the Fed's latest policy plans as dovish, extending expectations of a more accommodative backdrop. Regionally, US equities continued to make strong gains, assisted by a bumper earnings season. Our allocation to insurance contributed strongly to performance with Polar Capital Global Insurance returning 4.7%, slightly outperforming its sector, whilst our core US manager, Findlay Park, and our European manager, JO Hambro, both underperformed.

The fixed income positions delivered positive returns in aggregate despite the Bloomberg Global Aggregate Index producing negative returns. PIMCO Income returned 0.4%, benefiting from its exposure to credit and EM which performed well in the month.

Within commodities, gold had a volatile month but managed to recoup some losses to end the month down 0.6%.

## ACTIVE MANAGER IN FOCUS

### MW ESG (Market Neutral) TOPS UCITS Fund

The MW ESG (Market Neutral) TOPS strategy is an ESG derivation of Marshall Wace's (MW) long standing TOPS strategy. TOPS blends fundamentally underpinned trade ideas from the sell side community with sophisticated optimization, portfolio construction and risk management. Whilst this is a new strategy, it leverages the same core engine and quantitative intelligence that has been accumulated and developed by MW over the last 20 years.

The strategy has been tailored to suit an ESG investor through: onboarding ESG focused sell side analysts to generate fundamentally underpinned ESG trade ideas; introducing exclusions and restrictions on exposure to certain industries; supplementing trade ideas with proprietary signals linked to ESG factors and introducing ESG scoring at the portfolio construction stage.

The strategy is expected to be under constant evolution due to ongoing quant analysis, increases in and improvement in ESG data, and additional onboarding of sell side analysts.
