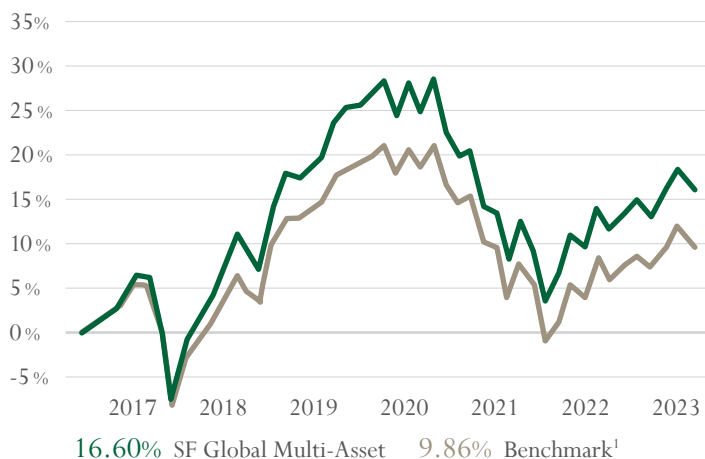

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned **-1.4% in August vs -1.7% for the benchmark**. Global equities fell in August amid rising sovereign bond yields and soft macroeconomic data in China. The US outperformed international markets, as economic data remained solid, especially within the labour markets as monthly jobs growth remained healthy. Inflation continued to soften in the US, which contrasts to Europe where it remained at an elevated level, adding to stagflationary fears in the region. Emerging markets underperformed as investment activity and retail sales fell sharply in China, despite stimulus efforts from the government.

The equity book delivered negative absolute returns, but fell less than broader equity markets. The more defensive strategies held up well, including Stonehage Global Best Ideas (GBI) and Polar Insurance. We also saw good performance from Driehaus US Small Cap relative to their smaller company universe, as they saw better returns from their biotechnology and personal care holdings. The worst performer over the month was Veritas Asia, which has been more leaning more heavily into the Chinese consumer.

Within the fixed income book, absolute returns were also negative as developed market sovereign bond yields rose with Central Banks suggesting that future rate hikes remain possible. Credit was also weak as risk sentiment turned more negative.

It was a mixed month for the Alternatives book, which was close to flat in aggregate. Weaker performances from the gold position and Marshall Wace. It was a mixed month for the Alternatives book although it was positive in aggregate. Weaker performance from Lxyor/Sandler US Equity Fund was more than offset by better performances from GAM Star Cat Bond and our holding in gold.

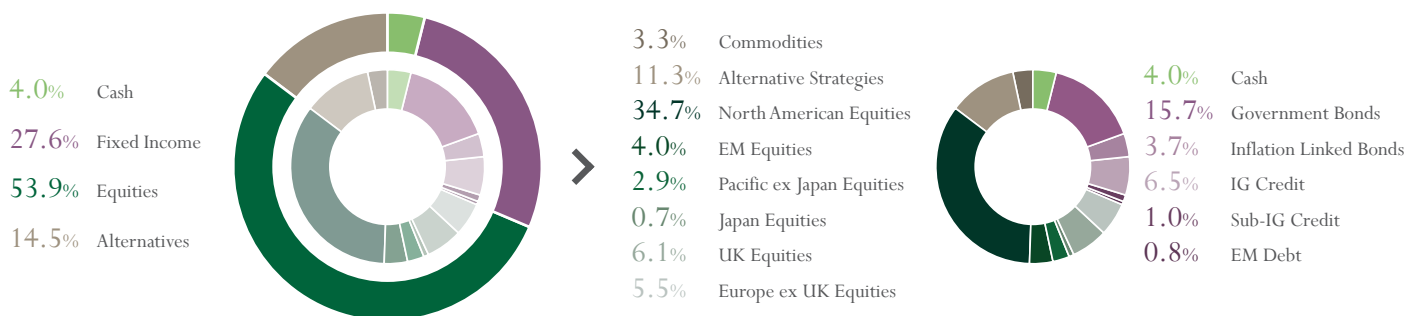
