

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned 1.5% in February vs 1.2% for the benchmark.

Global equities recorded strong gains following positive earnings results and a rebound in Chinese equities, whilst global bond markets declined as investors priced out interest rate cuts further in to 2024.

Asset allocation for the fund was positive in February, with the fund benefiting from its underweight exposure to fixed income and its slightly overweight exposure to equities.

The equity component posted positive returns but trailed broader equity markets. We again saw good returns from our holdings in the US, particularly our small-cap growth manager Driehaus which bucked the trend of small-cap underperformance as it benefited from holdings in biotechnology as well as stocks linked to the AI theme. However, funds such as JOHCM European Select Values which has more cyclicality and exposure to mid-sized and smaller companies underperformed wider markets.

The longer duration positions in US Treasuries in the fixed income portfolio underperformed in the rising yield environment.

Within alternatives, it was a strong month for Amundi Sandler US Equity which participated in equity market returns due to their increased net equity exposure and which also had some good short-side attribution. Gold had a more difficult month with the increase in rates and strengthening US Dollar.
